

## CCA Plaque Information

**The Chihuahua Club of America offers the following plaques to member local Chihuahua Clubs for their specialties:**

1. **Best of Breed** - for clubs holding independent specialties.
2. **Best of Variety** - for clubs holding specialties in conjunction with an all-breed show when Best of Breed cannot be offered, and
3. **High in Trial** - for clubs offering obedience at their independent specialties.

The local club's Secretary, Show

Chair, and/or Trophy Chair may not be members of the CCA and may be unaware of CCA's requirements for obtaining the plaque. CCA MEMBERS, please make sure that they ALL KNOW the following information:

### **To receive CCA plaque:**

1. Your club's request (Letter and Premium List) for a plaque(s) MUST reach CCA's Secretary At Least Four (4) Weeks Prior to your event. (Some clubs include CCA's Secretary on their mailing lists to insure that the premium list is received by CCA's deadline.)
2. Each CCA trophy MUST be Published in the actual Premium List, even though a club may use a Condensed premium list for other trophies. The premium list MUST state "Best of Breed" or "Best of Variety" ("Long Coat" and "Smooth Coat") and "High in Trial" - plaque offered by the Chihuahua Club


of America, Inc.

3. **Deadline:** At Least 4 Weeks Prior to your event, mail or Fax CCA's Secretary the request for the plaque for your specialty. Include the DATE of the event and the Name & Address of the person to whom the plaque(s) should be mailed. Your letter may be sent early, however, until CCA's Secretary receives the premium list, no plaque(s) can be mailed.

4. Due to the cost, plaques will not be sent overnight or by express.



# CCA Board Meeting by Conference Call, Tuesday June 30, 2009

**The meeting was called to order by President, Bruce Shirky at 8:05 pm EDT.**

Present were: Bruce Shirky; Peggy Wilson; Craig Leslie; Patricia Witter; Patricia Larrissey; Shirley Banderet; Kyle Potts; Hazel Bellerjeau; James Lehman; Ken Saenz and Dick Dickerson.

Absent was: Jill Hopper

Shirley Banderet made a motion to approve the minutes of the May 1st, 2009 Board meeting, with the exception of a spelling error which will be corrected. Dick Dickerson seconded. Motion passed.

**President's Report:** Bruce was requested to do a 200 word history of the breed for 125th Anniversary of the gazette. He used a picture of Becky Liscum-Rosson from 1965 showing in Junior Handling.

**Secretary's report:** A letter and ballot for the Lifetime Achievement Awards was received from AKC. The supporting documentation was sent to the Board members. The Secretary will ask for a vote on this matter by Sept 1st.

**Treasurer's report:** The balance in the checking account is \$9,243.41; Rescue \$2,080.37; Juniors/Ways & Means \$4,051.89; Chi Health Related Issues \$20,167.89; Purina \$2,643.10; and Ameriprise \$51,685.21 for a total of \$89,871.87. This total includes checks written for the purchase of BOB plaques and payment for the Chi-Chatter.

Pat Witter requested we deviate from agenda so she can work on handbook, while listening to the meeting. The Board agreed.

Pat Witter established a Paypal account for dues renewal. The renewal form must be filled out and a check mark made, indicating that the member agrees to abide by the Code of Ethics, before the dues can be paid. Shirley Banderet made a motion to accept the 2010 renewal forms, and accept Paypal for dues renewal. Craig Leslie seconded. Motion passed unanimously.

Pat Witter suggested we allow the Website Committee members to select a new website host when the current contract expires in July. Kyle Potts made a motion that the website committee be allowed to spend up to \$71.40 a year on their choice of website host. Shirley Banderet seconded. Motion passed unanimously.

Peggy Wilson will contact Pat Hastings to firm up a schedule for the seminar. Kyle Potts made a motion to put the seminar form on website when details are ironed out. Pat Larrissey seconded. Motion passed.

Information on the seminar will be put in the seminar section of the Gazette. Kyle Potts made a motion to charge a \$50 fee for non-members to attend the seminar. Pat Witter seconded. Motion passed.

Jim Lehman made a motion that we advertise in Dog Fancy only. Peggy Wilson seconded. Motion passed, Kenny Saenz opposed.

We have had several requests to pay for handbooks through Paypal, especially from foreign members. Foreign members will contact Jennifer Smolarz, who will give them a figure including postage and Paypal fees. Dick Dickerson made a motion to accept Paypal for the Handbook. Kenny Saenz seconded. Motion passed.

## **Unfinished Business:**

The CCA Board disbanded the Constitution committee.

Kenny Saenz & Kyle Potts will revamp the committee liasions.

Kenny Saenz will put together a presentation for the Board and Membership in October on the Top 20 for possible inclusion at the Spring 2011 Rotating.

Craig Leslie made a motion to accept Beverly LaFleur as Chi-Chatter Editor. Dick Dickerson seconded. Motion passed unanimously. The Chi-Chatter deadline of August 15th needs to be put on website.

## **New Business:**

Susan Ritenour sent the nominations for Outstanding Service and Outstanding Sportsmanship awards for 2009 to the Board.

Shirley Banderet will receive the 2009 Outstanding Service Award.

Donna J. Jensen will receive the 2009 Outstanding Sportsmanship Award.

The Board voted to furnish medallions for conformation at the AKC/Eukanuba National Championship in December. Pat Larrissey will check with AKC to see if any chihuahuas will be invited for Obedience and/or Agility. Craig Leslie made a motion to furnish the medallions for each variety, and offer an Obedience and/or Agility medallion, if chihuahuas will be competing in those events, to a maximum of \$290.00. Shirley Banderet seconded. Motion carried.

Craig Leslie brought up the subject that several of our judges would prefer to only award 1st in the Veteran classes. Jim Lehman made a motion to only award 1st in the Veteran classes, conditional on it being okayed by AKC. Kyle Potts seconded. Motion passed unanimously.

Amateur/Owner/Handler is a new class that many of our newer members might enjoy entering. Jim Lehman made a motion to add that class to our specialties. Kenny Saenz seconded. Motion passed.

**Committee Selection:** Kyle Potts, Chair; Dick Dickerson; Craig Leslie; and

**Chi-Chatter**



Kenny Saenz will work to come up with a Committee selection process that does not put pressure on the Board to fill all committees within 30 days of the Election.

**Permission for Rotating Schedule:** Craig Leslie received a June 11th e-mail from Michael LaVallee, giving us permission to hold both the Host club and CCA Sweepstakes on Thursdays at our Spring Rotating Specialties. This question has come up in the past. Jim Lehman made a motion that the letter from Mr LaVallee be included in Officers "white noteboook". Craig Leslie seconded. Motion carried. It was also suggested that a copy of the letter be

sent with the application for the Spring Rotating each year.

Ken Saenz made a motion that we place an ad in 125th anniversary issue of the AKC Gazette at a cost of \$475. Peggy Wilson seconded. Motion passed, Pat Witter & Patricia Larrissey opposed. Bruce Shirky will check into what AKC wants the ad to contain and advise the Board.

Shirley Banderet made a motion to go into executive session at 10:05. Craig Leslie seconded.

The Board entered executive session at 10:08 pm EDST.

The Board came out of Executive session at 10:36 pm EDST.

Shirley Banderet made a motion to disband the Breed Referral committee and notify the members that we are referring inquiries to the Breeders Directory on the CCA website. Kyle Potts seconded. Motion passed. The listing will also be removed from Chi-Chatter.

Dick Dickerson made a motion to adjourn. The meeting was adjourned at 10:42 pm EDST.

## CCA Board Meeting by Conference Call, Monday September 14, 2009

**The meeting was called to order at 8:07 EDST by President, Bruce Shirky**

Present were: Bruce Shirky; Pat Larrissey; Shirley Banderet; Kenny Saenz; Hazel Bellerjeau; Jill Hopper; Kyle Potts; Pat Witter; Craig Leslie & Peggy Wilson. Jim Lehman & Richard Bellon joined the meeting at 8:28 pm.

Dick Dickerson joined the meeting at 8:42 pm. Guests Sherri Chavez & Dena Muenzler

Absent: none

Kyle Potts made a motion to accept the minutes of the June 30th, 2009 Board meeting as printed. Kenny Saenz seconded. Motion carried.

**President's Report:** Several topics will be covered in the agenda, otherwise he had no report.

**Secretary's Report:** The applications for the Spring Rotating for CCA and CCM were mailed to AKC.

**Treasurer's Report:** Pat Witter reported the following balances: CCA Regular Checking- \$9,361.95; CCA CHRI Fund-\$20,173.04; CCA Rescue Fund-\$2,180.62; CCA Ways & Means-\$3,802.39; Purina

Funds-\$1,543.41; CCA Trophy Fund-\$1,805.01; Ameriprise Financial - as of 8/21/9 \$51,781.81; Total-\$90,628.43. There is also \$4,985.88 left in the handbook account, to cover shipping the handbooks to Chicago.

### **Committee Reports:**

**Ways & Means:** Dena Muenzler gave a report on the raffle tickets. She had 1,500 tickets made in 250 books, which means we have a projected profit of \$3,195.40. Donations were received from the Dallas, Texas, Greater New York, and Hawaii Chihuahua Clubs totalling \$240.00. So far the presale has been \$425.72. Tickets were sent to all Board members. Tickets were also sent to our Junior members, and a prize is offered for the Junior selling the most tickets. We want the Juniors to get more involved in Ways and Means, since these fund raisers are for their benefit. 25 chihuahua throws will also be for sale in Chicago.

**Handbook:** Sherri Chavez said the 500 handbooks will be published and trucked to the Marriott hotel in Chicago to hopefully arrive on September 28th or 29th. The hotel advised that after 5 boxes, there is a \$5.00 per box charge

for storage, so there will be a \$150.00 charge for storage and handling of 30 of the 35 boxes.

Sherri has requested the cost of shipping the boxes, but has not received an answer as yet. 156 handbooks have been purchased via the pre-sale, which more than the entire sale of 2005 handbooks.

**Committee Liaison:** Kenny Saenz made a presentation of a reorganization of the committees. Each committee head would report to either a Board member, a Vice-President, the Show Chair, or directly to the Board. The liaison's would in turn report to the Board monthly. Kenny Saenz made a motion to accept the reorganization. Pat Witter seconded. Craig Leslie, Patricia Witter, Kyle Potts, Hazel Bellerjeau, James Lehman, Jill Hopper, and Ken Saenz voted YES. Patricia Larrissey, Shirley Banderet & Peggy Wilson abstained. Motion passed. The

reorganization will be presented to the Membership at the General Meeting.

Kyle Potts gave reports on the following committees: Judges' Education-Billy Miller & Randy Carr are working on a standardized Judges Education packet to be handed out at the seminars, and updating the Illustrated Standard; RV Parking-all 10 spots have been filled and there is a waiting list; Welcome Reception and Banquet-Pat Holzkopf has arranged to meet with the hotel to make final arrangements, only 13 banquet reservations had been received as of Sept 4th; Events- Michael Holzkopf will be issuing a copy of the Rules of Misconduct to his committee in Chicago. 

# Chihuahua Club Of America National Specialty

***I** t was an honor to judge the Chihuahua Club of America National Specialty, and I will admit that I was surprised at the depth of quality of the entries.*

Overall, the Smooth Coat variety was more consistent in type and size, although not necessarily in quality. Both varieties were far above the norm, which is a blessing for a judge. Since I judge just about every weekend, it is nice to have choices in the classes, as well as in Best of Breed. Thank you all for entering! In fact, of all the entries there were only three or four that I would not want to own.

Additionally, I would like to take this opportunity to thank the parent club for your approval of the year-old revised

Chihuahua standard. Although I have judged these many years to the new standard, it was wonderful to see it in print. The Chihuahua is a toy breed but can and should be built like the larger dogs with a good shoulder layback and matching rears and should have good reach and drive when moving.

It is as true with Chihuahuas as it is with all breeds, that this correct layback of shoulders is the hardest ideal to breed and I looked for this second only to breed type and balance. In judging I have to first have good "breed type" and then I looked for proper layback with matching rears, a good firm topline and then hopefully good sound movement.

Good breed type means that head alone will identify the breed, along with proper size and proportion. Most heads

met the standard in that there were many apple dome skulls with large erect ears. I still recall one exhibit with a perfect body and gait but not a correct head.

Chihuahuas are to be somewhat longer than tall, but they should not be long in back. This is one area that could use improvement in both varieties. Most exhibits had good side gaits and very few had the dreaded "hackney" gait. This aspect has improved over the years.

I have been judging Chihuahuas since 1986 and I am proud to say that your breed is one of the three toy breeds that have improved the most.



## 11. Future Non-Dog Related plans?


I am considering becoming a professional pianist if I don't get accepted into vet school.

# AKC Delegates Report

## **The September 15, 2009 Delegates meeting was held at the Sheridan in Newark New Jersey.**

AKC Board Member Alan Kalter opened the forum prior to the meeting with a presentation on the newly proposed Grand Champion title proposed by staff and to be voted on at the December Delegates meeting. The Grand Champion title could lead to larger entries at shows, which would create a financial advantage as well as increase the number of quality exhibits in the ring. It would also give exhibitors with a limited number of dogs a way to stay active in Conformation.

After the forum the meeting opened and the Delegate Standing Committee elections were held.

The Delegates referred the rule changes necessary for the proposed realignment of the Groups back to the AKC Board. It is to come back to the Delegates for a vote in March 2010.

The Delegates voted to amend Chapter 3, Section 5, of the Rules Applying to Dog Shows permitting the optional division of the 12-18 Month Class, 12-15 & 15 -18 effective July 1, 2010

Chapter 8, Section 9 of the Retriever Field Trial Rules was amended to cover

all contagious and communicable diseases.

The following Clubs were honored and presented with plaques to recognize their 100th Anniversary as AKC member clubs: Chicago Collie Club, Greyhound Club of America, Pekingese Club of America and West Highland White Terrier Club of America.

The President gave an update on the upcoming Meet the Breeds to be held at the Javits Center October 17 & 18, 2009

Viola and I were asked by the Board to organize the Chihuahua booth. With the help of Jill Hopper who was kind enough to lend us the beautiful backdrops for the booth we were able to put together a representative breed booth. CCA members Ada Nieves, Jane O'Halloran and Grace Sette worked the booth on Saturday and Josephine De Menna, Pamela Mannes, Ada Nieves and Jane O'Halloran were with us on Sunday. Ada and Jane had Chihuahuas dressed in different costumes and I was surprised at the stamina of two of my puppies a long coat and a smooth coat who spent the two days from 9AM to 5 PM going from hand to hand having their pictures taken while their tails never stopped wagging. The event was an unparalleled success resulting from the participation of nearly 200 dog

clubs and cat councils and the support of over 100 vendors and the sponsor Pet Partners, Inc.

Over 36,000 people attended the well covered event which showcased the joys of pet ownership to an audience of dog and cat lovers who were eager to learn about the diversity of breeds and responsible pet ownership in a welcoming and positive setting. This family friendly event educated children of all ages including local Girl, Boy and Cub Scout troops. The publicity generated by the event reached more than 300 million people with the Meet the Breeds message; the first step in responsible pet ownership is to "meet the breed" which entails doing research and selecting a pet that fits your lifestyle.

All of us who manned the Chihuahua Booth were proud to represent our Parent Club in the breed booth and the demonstration rings and are looking forward to being able to participate next year if asked.

The next delegates meeting will be held in December in Long Beach.





**Specifically, I further pledge:**

- **To uphold the American Kennel Club rules applying to Dog Shows and Registration, particularly as regards to the maintenance of complete and accurate breeding records.**
- **To accept and uphold the Standard of the Chihuahua as developed by The Chihuahua Club of America and approved by the American Kennel Club.**
- **To breed only A.K.C. registered Chihuahuas (does not apply to foreign members) with the aim of maintaining or improving the qualities of the breed as set forth in the Standard, and not for personal gain. I will not participate in the buying or selling of dogs at auctions and I will never knowingly sell puppies to wholesalers, laboratories or to pet stores, and will encourage any puppy buyer to behave similarly. To serve as an example of good sportsmanship in every aspect of the sport of dogs, and to assist and befriend newcomers and novices to the best of my ability.**
- **To keep myself informed in the areas of dog health and genetics and to carefully screen all breeding stock for hereditary faults or disqualifying defects, removing any questionable animals from my breeding program. This includes cardiac, patella and eye testing as recommended by the Canine Health Foundation's CHIC program.**
- **To conduct all my kennel practices in a clear, honorable and open fashion, and to use written agreements or contracts whenever possible.**

# Chihuahua Club Of America Guidelines For Hotel Maintenance

**NOTE:** *Because some dog people have been irresponsible in safeguarding the property of hotels, it is increasingly difficult to acquire suitable housing for our shows, our members and our dogs.* For this reason, the C.C.A. has issued the following guidelines for exhibitors to ensure that we are welcomed at hotels.

- If dogs are to be exercised in the rooms, this **MUST** be done in exercise pens. Do not blockage the bathroom, or closet, for example to accomplish this. To setup exercise pens, use heavy plastic as a base, with multiple layers of newspapers on top. Then place the exercise pen on top of the papers. The heavy duty plastic is pulled up above the "piddle" line (about 8 to 10 inches) and secured with clips or clothes pins. Soiled papers must be removed and placed in plastic bags for ease of disposal. Do not expect housekeepers to have to touch any soiled papers, and soiled papers must not be merely placed in the wastepaper baskets, as the scent of excreta and urine will penetrate the wastebaskets. All rooms must be kept clean and smell clean.

This protects curtains and furniture.

- When dogs are left alone in the rooms, they must be left in their individual crates. Even "non-climbing" dogs have been known to climb out of their exercise pens when left in strange areas. And "digging" dogs have dug their way through the plastic and continued digging through the carpeting. This requirement of keeping dogs in their crates, thus protects the animals from escaping when the housekeepers come in, and of course, protects the furnishings.
- Dogs must not be allowed to run free in the room, whether the owner is present or not. Many a dog becomes suddenly un-housebroken when it encounters strange odors in strange places.
- Owners/Exhibitors should bring their own toweling for bathing the dogs. Hotel equipment must not be used for cleaning up accidents, ownersexhibitors must provide their own cleanup material, i.e. paper towels, vinegar, "Fantastic" and the like.
- Most hotels that permit the use of their facilities for dog shows have a policy limiting the number of dogs allowed per room. There will be a maximum of ten (10) dogs per room. This will be

strictly enforced.

- No dogs will be allowed on any carpeting, including rugs, halls, guest rooms, showroom, etc.
- No exercising of dogs (outside) in any areas, except those areas posted with signs as dog areas. Each person is responsible for cleaning up after their dog, inside and outside of the motel.
- No dogs allowed outside of their crates, unless in an x-pen w/plastic, or in the show ring.
- No dogs allowed in the lounge, lobby, banquet/meeting rooms and restaurants.
- Dogs must be carried in and out through designated exits/entrances only.
- The only breed of dog that is allowed in the hotel is the Chihuahua. NO other animals will be allowed.
- Rooms must be made available for maids to clean daily. Do not disturb signs will NOT be honored during the day.

NOTE: A Committee appointed by the Chihuahua Club of America, and/or host club will be doing random checks each day. Anyone violating the above guidelines will be asked to leave the hotel/motel immediately.






