CCA Plaque Information

The Chihuahua Club of America offers the following plaques to member local Chihuahua Clubs for their specialties:

- 1. **Best of Breed** for clubs holding independent specialties.
- 2. **Best of Variety** for clubs holding specialties in conjunction with an allbreed show when Best of Breed cannot be offered, and
- 3. **High in Trial** for clubs offering obedience at their independent



specialties.

The local club's Secretary, Show Chair, and/or Trophy Chair may not be members of the CCA and may be unaware of CCA's requirements for obtaining the plaque. CCA MEMBERS, please make sure that they ALL KNOW the following information:

To receive CCA plaque:

- 1. Your club's request (Letter and Premium List) for a plaque(s MUST reach CCA's Secretary At Least Four (4) Weeks Prior to your event. (Some clubs include CCA's Secretary on their mailing lists to insure that the premium list is received by CCA's deadline.)
- 2. Each CCA trophy MUST be Published in the actual Premium List, even though a club may use a Condensed premium list for other trophies. The

- premium list MUST state "Best if Breed" or "Best of Variety" ("Long Coat" and "Smooth Coat") and "High in Trial" plaque offered by the Chihuahua Club of America, Inc.
- 3. Deadline: At Least 4 Weeks Prior to your event, mail or Fax CCA's Secretary the request for the plaque for your specialty. Include the DATE of the event and the Name & Address of the person to whom the plaque(s should be mailed. Your letter may be sent early, however, until CCA's Secretary receives the premium list, no plaque(s can be mailed.
- 4. Due to the cost, plaques will not be sent overnight or by express.

Chihuahua Club of America Board Meeting by Conference Call, Monday April 26, 2010*

The meeting was called to order at 8:06 pm EDST by President, Bruce Shirky

Present were: Bruce Shirky; Kyle Potts; Craig Leslie; Patricia Larrissey; Patricia Witter; Dick Dickerson; Ken Saenz; Myrle Hale; Jackie Dew; Peggy Wilson; and Parlimentarian, Richard Bellon.

Absent were: Jill Hopper & Susan Payne

President's Report: A check for slightly over \$5,000 was received from the Purina Weight Circle Program.

Secretary's Report: A dues extension was requested by Bert Custodio who was out of the country for 3 months, and whose dues lapsed. It was pointed out that dues are due on or before January 1st, which was more than 3 months ago. The Board agreed that we must follow our Constitution and By-Laws and the member must re-apply for membership.

Treasurer's Report: As of April 25th we have \$17,038.98 in the checking account; \$21,253.15 in the Chihuahua Health Related Issues Fund; \$2,226.21 in the Rescue Fund; \$6,386.18 in Ways and Means; \$6,774.06 in the Purina Funds; and \$425.73 in the Trophy Fund. The Ameriprise balance is \$51,923.91 for a total of \$106,028.22.

Committee Reports:

Top 20: Kenny will have full information at the Rotating, when the Board and Membership can consider whether to hold the event.

Show Committee: Craig Leslie reported that only 85 room nights have been reserved at The Metropolitan Hotel thus far, we need 380 nights reserved in order to get the show room and comp rooms. Also, only 5 banquet reservations have been received thus far. Trophy donations are needed, even if members can send \$5-10 it will help. Auction

items are also needed, and should be sent to Lisa Knop. Some members did not receive premium lists, even though the membership list was send to Roy Jones. Pat Witter offered to make labels to send to the Superintendent for future specialties. Craig asked that each Regional V.P. put a notice on their regional list, asking for trophy donations, auction items and asking members to make their hotel and banquet reservations.

Code of Ethics: Myrle Hale gave a report on the work of the Code of Ethics committee. She asked that comments and suggestions made to the Board and on the V.P.'s regional lists be forwarded to her. The committee will meet and submit a suggested Code of Ethics to the Board for further review.

Unfinished Business:

Scholarship Advisory Committee:

The Board affirmed that the committee members are: Lynnie Bunten; John Cipollina; Joe & Margaret Eoff; Carole Jeffrey; Craig Leslie; Billy Miller; Richard Miller; Becky Rosson; and Peggy Wilson. Scholarship requests and documentation should be sent to the Juniors Chair, Randi Berthold.

Peggy Wilson made a motion to confirm the e-mail vote to join the Canine Health Foundation. Myrle Hale seconded. Motion passed unanimously.

Myrle Hale made a motion to confirm the e-mail vote approving the January 25, 2010 minutes. Kenny Saenz seconded. Motion passed unanimously.

Craig Leslie made a motion to confirm the e-mail vote to support the Canine Encephalitis study by doing cheek swabs at the National. Kyle Potts seconded. Motion passed unanimously.

The charges brought against Patricia Regnier were withdrawn by the person bringing the charges.

New Business:

There was a discussion of AKC's

proposal to allow deaf dogs to compete in Performance events. Patricia Witter made a motion that we vote not to allow the participation of deaf dogs in Performance events. Craig Leslie seconded. Motion passed unanimously.

Gilbert's K-9 seminar: Craig Leslie made a motion that Peggy Wilson hire the Gilbert's to present their K-9 Mini Seminiar "Challenging The Myths" on Thursday October 7th, and offer them 2 nights lodging, rather than the 3 they are requesting. Pat Witter seconded. Motion passed unanimously. Peggy Wilson was asked to inform the Giberts that we do not charge our members for the seminar. We will offer the seminar to nonmembers for the same fee as last year.

Health: Pat Witter received a request from Health Chair, Beverly Fritzler DVM, for information on the funds available for the Health Committee to purchase items for the CHIC program and to purchase something for a fund raiser, as well as for research, etc. Dr Fritzler also sent the Board a list of several health studies that are requesting \$2500 in support, and recommended 3 of them, Mitral Valve disease, Cryptorchidism and Legg-Calve-Perthes.

The Board requested that Dr Fritzler contact the AKC Health Fund, see what funds we have available, and make specific requests for where those funds will be distributed. She should also request the needed funds for the CHIC items, from the Board. The Board did not feel that the Health Committee should waste their time on fund raisers, as they receive member donations and a portion of the Purina funds.

Bruce Shirky will contact our AKC Rep., Rey Burgos regarding his vote on several issues.

Dick Dickerson made a motion to adjourn at 9:34 pm EDST.

A small breed is easier to handle. My mother always handled larger breed dogs, so a small dog was something different.

he 2009 Chihuahua Club of America health survey revealed an alarming number of "seizures of unknown origin", technically referred to as Idiopathic Epilepsy. Idiopathic is defined as "Arising from an unknown cause". 45% of survey participants had bred or owned a Chihuahua with seizures of unknown origin with an average of 2 dogs per breeder/owner affected by the condition. One breeder had 20 Chihuahuas affected out of 30 litters. Another two affected Chihuahuas were noted as being sired by the same dog.

A number of researchers have conducted pedigree analyses on specific breeds and these analyses have found strong evidence that idiopathic epilepsy is in fact an inherited genetic condition2. A genetic factor may be highly suspected when seizures occur in dogs 1 to 3 years of age. In Vizlas it appears to be inherited as a simple autosomal recessive trait although polygenic inheritance has not been ruled out completely.3 Test breedings of epileptic dams and sires done by veterinary researchers have produced incidences of epilepsy in the offspring ranging from between 38 percent (a study of three different epileptic bitches outcrossed to a single epileptic sire) to 100 percent (a mating of two epileptic siblings).5 Epilepsy in the Belgian Tervueren and Belgian Sheepdog has been found to be polygenic with a single locus of large effect.9

In addition to external metabolic influences, there are internal factors in a neuron that regulate how excitable each cell is in the brain. The makeup of



all the internal machinery of the neuron and its interactions with its neighbors is determined by the genetics of the animal. A mutation in certain genes can cause these cells to be more excitable and thus more likely to slip over the threshold into seizures. This is presumed to be the basis of hereditary epilepsy.10

All dogs have a seizure threshold. A seizure occurs when this threshold is exceeded. Seizures may be caused by a stimulus such as hormones (estrogen can lower the threshold to seizures in parts of the brain⁵), fatigue, injury, a fight with another dog, or even breeding. Seizures may also occur spontaneously.

Dr. Alexander de Lahunta of Cornell University and others suggest that each animal inherits a "genetically determined predisposition to seizures", and that seizures occur when this threshold is exceeded.⁶ In other words, a physical condition which may cause seizures in a low-threshold animal may not cause seizures in a "normal" animal. The seizure threshold is apparently exceptionally low in animals that suffer from idiopathic epilepsy.⁷

In order to be diagnosed with Idiopathic Epilepsy, other conditions must first be ruled out as the cause of seizures. Seizure inducing conditions include:

- · Brain tumor-Most common cause of seizures that begin after age 58 MRI can rule out.
- Distemper-Can determine by CSF analysis. Suggested to do while pet is already under anesthesia for MRI.
- Encephalitis-Can be diagnosed by CSF analysis.
- Exposure to toxins-rat poison, some plants, pesticides, herbicides, drugs, etc

- Garbage poisoning-Staphylococcal or botulism toxins can cause central nervous system stimulation and result in seizures.
- · Head injury An injury to the skull, possibly hard enough to crack the skull would require a significant impact to cause an intracranial disturbance. If such an event did occur, then, if seizures were to occur, they will not be observed immediately. The dog would not have seizures until weeks, or even months after the event. An MRI would show an abrasion on the skull. Anticonvulsant drugs would be ineffective.5
- Hydrocephalus-Ultrasound can be performed by scanning through the fontanel to detect excessive accumulation of fluid within the brain.
- · Hyperkalemia-High concentration of potassium in the blood. Bloodwork can rule out.
- Hypocalcemia-Can be detected with a simple blood test.
- Hypoglycemia-responds to glucose, epilepsy does not.
- Hypothyroidism-Jean Dodd recommends a thorough panel: T4, free T4, T3, free T3, T3 and T4 autoantibodies plus thyroglobulin autoantibody and TSH where indicated.
- Hypoxia-Lack of oxygen. Can be result of heart or lung disease which can be ruled out with bloodwork and x-rays.
- Kidney disease-Acidosis can result in buildup of toxins in the blood which may cause seizures. Kidney health can be determined through blood tests.
- Liver disease-Portosystemic Shunt falls into this category. Excess ammonia in the blood can cause seizures. Blood ammonia levels can be measured.

- Lead poisoning-can be from tiny particles of dust from degenerating paint. Blood can be tested for lead levels.
- Lyme disease and Rocky Mountain Spotted Fever- Can be detected with blood tests.
- Toxoplasmosis- Blood test can rule out.

Hopefully Chihuahua breeders will not fall prey to the ostrich syndrome described in C.A.Sharp's The Road To Hell: Epilepsy and the Australian Shepherd. "It's something in your water"..."You gave him a vaccination"... "She got stung or bitten by something"... "You're feeding the wrong food"..."The garden shed door was open, he must have gotten into something"..."She hit her head" ... And so on... There are many things that can cause seizures. Thorough veterinary follow-up is required so that the dog can receive proper treatment. While the excuses above do indicate other possible causes, most are unlikely to cause long-term repeated seizure episodes, would have additional symptoms, and/ or could be identified through testing. The "idiopathic" label has played directly into the hands of those suffering from Ostrich syndrome. Since there is no positive test, a dog with recurring seizures surely must have something else. No matter what tests have been run, there will be something Ostriches can point to that wasn't done or can't be followed up on allowing them to exonerate their dogs' genes.9 The list above clearly states how to rule out most of the conditions as the causes of seizure activity in a dog. Epileptic dogs should never be used for breeding. Until we know how epilepsy is inherited, serious thought should also be given as to whether or not to continue breeding parents or siblings of an affected dog.

The Canine Epilepsy Project is a study supported by grants from the AKC Canine Health Foundation, National Institutes of Health, Individual breed

clubs and private donations. The project's goal is to find the genes responsible for epilepsy, the mode of inheritance and hopefully a DNA marker test, so that wise breeding can decrease the incidence of the disease in dogs.

The Canine Epilepsy Project researchers need samples from dogs that have experienced seizures and immediate relatives, both normal and affected. Specifically they need samples from all available siblings, parents and grandparents and also any offspring and mates if bred. Participation in the study is free and confidential- the names of individual owners or dogs will not be revealed.

Unfortunately to date no Chihuahua samples have been received. According to the organizers of the project "The level of participation by any breed should not be interpreted as an indication of the frequency of this problem within the breed, but can serve to demonstrate the commitment by fanciers of that breed to help researchers solve this problem"4

Our health survey has revealed that without a doubt idiopathic epilepsy is an issue that needs to be addressed in our breed. Now it is time for Chihuahua fanciers to demonstrate their commitment to help researchers solve this problem. Please support the Canine Epilepsy project. AKC Delegates Report

he annual Delegates meeting was held in Elizabeth New Jersey on March 9th, 2010. With 405 member clubs represented it was one of the highest attended meetings. It is at this meeting that the elections for the Board seats are held.

The nominating committee candidates for the class of 2014 were Dr. Charles J. Garvin, representing Marion Ohio Kennel Club, Dr. William R. Newman representing the Mastiff Club of America and Patricia C. Scully representing the Obedience Training Club of Hawaii. Running from the floor by petition were Dr. Carmen I. Battaglia, representing the German Shepherd Dog Club of America and Steven D. Gladstone representing Reno Kennel Club. The first order of business was the casting of the ballots by the delegates.

With 198 votes needed for election the following were elected to the Board, Dr. Charles Garvin 238 votes, Patricia C. Scully 218 votes and Dr. William R. Newman 217 votes.

Dr.Carmen Battaglia received 175 votes and Steve Gladstone received 172 votes.

The next item was the approval of Member Clubs. The following clubs were approved as member of The American Kennel Club. Anatolian Shepherd Dog Club of America and Belle City Kennel Club.

Next on the agenda for a delegate vote was the amendment that would split the Sporting and Hound Groups, and the Non Sporting Group would be renamed the Companion Group and a

new Northern Group would be created. If this amendment were adopted all references to the number of Groups must be changed to accommodate the new number of Groups.

The chair called on Dr. Tom Davies, Vice President of the AKC Board and Chair of the Group Realignment Committee, who spoke as follows:

Thank you Mr. President. After the Delegates voted to defer the proposed amendment on realignment to this meeting, the Realignment Committee reconsidered its recommendations As the Chairmen of that committee I reported to the AKC Board in November that a majority of the committee felt that the matter needed further study. The committee continues to believe that the eventual realignment of the Group structure will be necessary, but based on the input from Parent Clubs and the fancy, the current proposal may not be ideal. In the best interests of the sport, the Committee suggests that the realignment proposal needs further discussion and refinement.

The influx of new breeds, six this year alone, along with the current list of FSS breeds that will likely be advanced in the near future as a result of recent Board action suggests that a reassessment of the Committee's recommendations may be necessary and desirable. Therefore I move that the proposed amendment be referred back to the Board.

There was a motion and a second and the motion passed.

The next vote was on an amendment that would eliminate the use of telegrams to change or cancel entries, as telegrams are now obsolete. The amendment was adopted.

The next vote was on the proposed amendment to Rules applying to Dog shows- Duties and Responsibilities of Show Veterinarians. This amendment would update the requirements for show veterinarians to better accommodate on call veterinarians and to require clubs to inform them of their duties. There were questions on the clarity of the wording and the Delegates voted to refer the matter back to the Dog Show Rules Committee.

Of interest to breeders is the Full Litter registration process adopted by the AKC. The full litter registration is not only easy to use but also save money. This process allows you to individually register all the puppies in the litter at the time of litter registration for a discounted price. This process also insures the long term health of the American Kennel Club since all the puppies in the litter are being registered.

The following advantages include:

- 1. A 29% discount on the average litter registration fee
- 2. A 40% discount on the dog registration fee for each dog registered
- 3. A streamlined process to complete the entire registration process
- 4. Ability to select the names of each individual puppy, ensuring kennel names are used appropriately

In addition to the Full Litter Registration there is also a second option for those who have already registered their litters. This is the Full Litter Offspring Registration Application This gives the breeder a second opportunity to individually register all the puppies at a discount,

The AKC listened to the concerns of breeders and made the following changes:

A rule change now allows the breeder to assign the limited designation to a dog after registration through the first transfer. The dog must have been first registered through the Full Litter Registration process.

If no plan has been previously activated the complimentary 60-day trial of the AKC Pet Healthcare Plan will be transferred to the new puppy owner.

- 3. Reservations will be confirmed before the Show Entry closing date.
- 4. Access to the parking lot will be from 4:00 PM on Wednesday before the show. Follow the signs to RV registration upon arrival to receive your assigned parking location.
- 5. Escort or tow vehicles will not be allowed to park in the motor home parking area. These vehicles must be parked in the hotel parking lot.
- 6. There are no electric, water or sewer hook-ups available.
- 7. All garbage should be disposed of properly. Garbage receptacles will be available in the parking area.
- Each exhibitor is responsible for keeping his assigned area clean during his stay. If your assigned area is not clean when you
 leave, the CCA Board may revoke your motor home parking privileges. The motor home parking area will be inspected at the
 conclusion of the show.
- 9. Absolutely no discharge of gray or black wastewater at the parking sight will be tolerated. Anyone discharging wastewater will be severely dealt with by the CCA board.

Chihuahua Club Of America Guidelines For Hotel Maintenance

OTE: Because some dog people have been irresponsible in safeguarding the property of hotels, it is increasingly difficult to acquire suitable housing for our shows, our members and our dogs. For this reason, the C.C.A. has issued the following guidelines for exhibitors to ensure that we are welcomed at hotels.

- If dogs are to be exercised in the rooms, this MUST be done in exercise pens. Do not blockage the bathroom, or closet, for example to accomplish this. To setup exercise pens, use heavy plastic as a base, with multiple layers of newspapers on top. Then place the exercise pen on top of the papers. The heavy duty plastic is pulled up above the "piddle" line (about 8 to 10 inches) and secured with clips or clothes pins. Soiled papers must be removed and placed in plastic bags for ease of disposal. Do not expect housekeepers to have to touch any soiled papers, and soiled papers must not be merely placed in the wastepaper baskets, as the scent of excreta and urine will penetrate the wastebaskets. All rooms must be kept clean and smell clean. This protects curtains and furniture.
- When dogs are left alone in the rooms, they must be left in their individual crates. Even "non-climbing" dogs have been known to climb out of their exercise pens when left in strange areas. And "digging" dogs have dug their way through the plastic and continued digging through the carpeting. This requirement of keeping dogs in their crates, thus protects the animals from escaping when the

- housekeepers come in, and of course, protects the furnishings.
- Dogs must not be allowed to run free in the room, whether the owner is present or not. Many a dog becomes suddenly un-housebroken when it encounters strange odors in strange places.
- Owners/Exhibitors should bring their own toweling for bathing the dogs. Hotel equipment must not be used for cleaning up accidents, ownersexhibitors must provide their own cleanup material, i.e. paper towels, vinegar, "Fantastic" and the like.
- Most hotels that permit the use of their facilities for dog shows have a policy limiting the number of dogs allowed per room. There will be a maximum of ten (10) dogs per room. This will be strictly enforced.
- No dogs will be allowed on any carpeting, including rugs, halls, guest rooms, showroom, etc.
- No exercising of dogs (outside) in any areas, except those areas posted with signs as dog areas. Each person is responsible for cleaning up after their dog, inside and outside of the motel.
- No dogs allowed outside of their crates, unless in an x-pen w/plastic, or in the show ring.
- No dogs allowed in the lounge, lobby, banquet/meeting rooms and restaurants.
- Dogs must be carried in and out through designated exits/entrances only.

- The only breed of dog that is allowed in the hotel is the Chihuahua. NO other animals will be allowed.
- Rooms must be made available for maids to clean daily. Do not disturb signs will NOT be honored during the day.

NOTE: A Committee appointed by the Chihuahua Club of America, and/or host club will be doing random checks each day. Anyone violating the above guidelines will be asked to leave the hotel/motel immediately.

Rescue Report By Lynnie Bunten, CCA Breed Rescue Referral Contact

ELP! Please help me find a new home for my Chihuahua.

I get numerous emails like that every day. It's really heartbreaking sometimes. Other times, I want to reach right through the computer and slap the writer silly. Oh wait, they are already silly. I want to slap sense into them. Let me share examples of both.

The heartbreaking cases are the ones where the family is breaking up due to death, divorce, loss of job, foreclosure, etc. The parent or grandparent has died or gone into a nursing home and no one in the family can or is willing to take the dog. Or one spouse has left the other with four children under the age of six, they've lost the house and are in an apartment, the dog is totally housebroken so he needs to be walked and with a job and four little ones the mother just cannot keep it all together. That's how Rafi came into rescue. This next is very common now. People have to move out of their homes and into an apartment or into housing with another family. The incoming dogs are either not allowed or are too many for the limits in the new housing. They have to find new homes. Normally, these dogs are pretty well behaved and should be easy to place, if we had enough foster homes in the meantime.

Now, for fun or for tears, depending on how you look at it, here are some of

the silly ones. "We're moving to another state and dogs aren't allowed there." "My new boyfriend doesn't like the dog." "I got this dog as a puppy and he pees on the carpet." My latest one is pretty good too. "My husband got Root Beer at the local fair and we are a busy family so we can't give him enough time." This dog is one year old, friendly, housebroken and young. The people sent him with a bunch of treats, a fancy canvas crate, a nice bed, pretty collar and such. They'd had him for a month around their young children and hadn't bothered to take him to the vet for a check up or shots. Luckily, this one is going to adopt easily. He's now neutered and fully vaccinated and ready to be put on the rescue website.

The ones I really hate are the ones where a dog is now 10 years old or older and the family wants to get rid of him. Add to it the ones with a history of biting and you see the kinds of fun I have in responding to them. Just for everyone's information, most rescues and shelters do not accept biters except to put them down. A dog with a history of biting is an extreme liability. Even if a rescue or foster home has managed to retrain the dog or avoid situations that trigger the biting, there is no way to control how the adoptive home will manage the dog. If the dog is adopted out and if it bites someone, a lawsuit could be brought against the adopting agency. That's not to say it would be won, but still would require a lot of money to defend.

If you are still reading this, I have a request of you. We do not have enough rescuers out there. If you'd like to help, talk to me about that. However, I've something that everyone can help with even if they don't want to bring rescued dogs into their own homes. I need the names of various good shelters by area. If you could look around your community and find out for me what shelters are no-kill, which ones have a pretty good record for care and adoption and any that use foster homes. Basically, I need resource lists for locations where no one that we know of is doing rescue.


