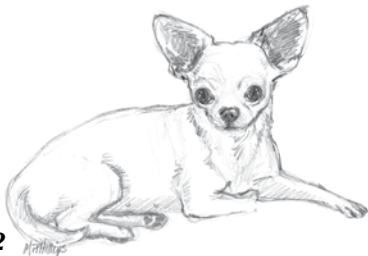

## **Delegates,**

In March, 2012 you will be asked to vote on an amendment to Chapter 16, Section 1 of the Rules Applying to Dog Shows. At the December meeting I indicated that it was to create a three point major at one national specialty each year for each breed, for the Reserve Winner's Dog and/or Bitch where there was a five point major in that sex. However, as indicated in the

November, 2011 AKC Board minutes, and as noticed with the agenda for the December, 2011 Delegate meeting, this three point major for a Reserve Winner would only be created if the number of dogs competing in the regular classes for that Reserve Winner's sex totals at least twice the number required for a five point major in the region in which the show is held.

The complete correct wording will be noticed on the February and March Secretary's pages, and in March, you will be asked to adopt the December minutes as so amended. An italicized editorial note will be added to the posted December, 2011 minutes showing the full text of the proposed amendment.

## **RULES APPLYING TO DOG SHOWS**

### **Chapter 16, Section 1**

#### **New Sixth Paragraph**

#### **Section 1. (New Sixth Paragraph)**

At one National Specialty each year, specified by the AKC Breed Parent

Specialty Club at the time the event application is submitted to AKC, the dog designated Reserve Winners Dog and the bitch designated Reserve Winners Bitch will be awarded a three-point major, provided that the number of dogs competing in the regular classes of the reserve Winner's sex totals at least twice the number required for a five point major, in the region in which the event is held.

How this translates for us is this way: In Chicago, the number needed for a 5 point major is

Chihuahuas (Long Coat) 12 dogs 14 bitches

Chihuahuas (Smooth Coat) 12 dogs 11 bitches

That would mean that if there were 24 dogs and 28 bitches entered in Long Coats or 24 dogs and 22 bitches in Smooth Coats, the Reserve Winners Dog and Bitch would receive a 3 point major for their win.

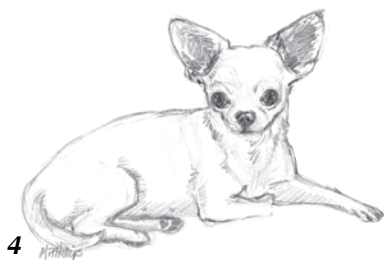
## Mission Statement

## CCA Plaque Information

*The Chihuahua Club of America offers the following plaques to member local Chihuahua Clubs for their specialties:*

1. **Best of Breed** - for clubs holding independent specialties.
2. **Best of Variety** - for clubs holding specialties in conjunction with an all-breed show when Best of Breed cannot be offered, and
3. **High in Trial** - for clubs offering obedience at their independent specialties.



The local club's Secretary, Show Chair, and/or Trophy Chair may not be members of the CCA and may be unaware of CCA's requirements for obtaining the plaque. CCA MEMBERS, please make sure that they ALL KNOW the following information:

### **To receive CCA plaque:**

1. Your club's request (Letter/e-mail and Premium List) for a plaque(s) MUST reach CCA's Awards Committee contact At Least Four (4) Weeks Prior to your event. (Some clubs include the contact person on their mailing lists to insure that the premium list is received by CCA's deadline.)
2. Each CCA trophy MUST be Published in the actual Premium List, even though a club may use a Condensed premium list for other trophies. The premium list MUST state "Best of Breed" or "Best of Variety"

("Long Coat" and "Smooth Coat") and "High in Trial" - plaque offered by the Chihuahua Club of America, Inc.

3. Deadline: At Least 4 Weeks Prior to your event, mail, e-mail or fax the Awards Committee contact the request for the plaque(s) for your specialty. Include the DATE of the event and the Name & Address of the person to whom the plaque(s) should be mailed. Your letter may be sent early, however, until the Awards contact receives the premium list, no plaques can be mailed.

4. Due to the cost, plaques will not be sent overnight or by express.

**New Business**

**Houston Spring Rotating Update**

Pat Witter reported that since Carol Jeffrey was not going to be able to attend the shows in Houston, selling catalogs will be done by board members. Pat will assign shifts.

Guidelines for Host Club receiving Purina funds:

A new requirement will be added to the guidelines for the Spring Rotating Host clubs. Any club that hosts a Spring Rotating show will be expected to show that they have made an effort to bring funds in to offset some of the expense

of the show. CCA gives 50% of the Purina check to the host club each year. That amount varies but is usually around \$2500. The clubs will be expected to have a mail or email drive for Advertising and Trophy donations, have some type of fund raiser over the course of the weekend and to put an ad in the Chi Chatter. Each of these four requirements will count as 25% toward the total amount of their check they receive from CCA. The Rotating Resource committee will be working on the wording of the new guideline and it will be added to the current document that is sent to clubs.

Michael H. suggested that the Specialty Resource committee be responsible for the wording of the above addition to the Host Club Guidelines

**Health Related Issues Fund** – disbursement guidelines

Pat Witter made a motion. The motion read:

The Chihuahua Club of America has established the Chihuahua Health Related Issues Fund, which is specifically designated for research that will benefit the Chihuahua. The CHRIF Committee should bring any proposal for research to the board of CCA, which should specifically include documentation on what is being proposed. The President will appoint a committee to review the research proposal and report back with their recommendations on whether to proceed or not at the next scheduled Board meeting.

This new Standing rule will insure that the funds in that account are used as they were originally intended when the account was set up. Craig Leslie seconded. A roll call vote of all members present was taken. Motion carried unanimously.

### **Video proposals**

Leah Monte presented the Board with a review of three companies that do dog show videos. One company, Dog Show Video Pros, does all the work and receives all the income. The dogs are identified on the video by subtitles. A second company, Purebred Studio provides services in which the club is more involved. The club selects narrators and purchases the videos and is responsible for marketing the video to the public. This is the company that did the video for the Rotating Specialty in Dallas. It involves a lot of work and is heavily dependent on committee participation. The third company was not seen to be as good as the first two.

The Board's recommendation is to

get a contract for the first choice, Dog Show Video Pros and bring it back to the Board in time to consider it for October 2012 in Chicago.

Craig asked how the Top Twenty in Chicago would impact the puppy match. Kenny's intention is to combine Top Twenty with the Saturday Banquet so there would be no conflict.

Kyle will ask Kenny to update Pat Witter and Michael regarding the Top 20 and Banquet.

Craig asked if there's any way to get credit for RVs in room count. Not done yet. We didn't get comped rooms this year. Pat Witter and Michael will check into this.

At 7:17 p.m. The Board recessed to go into executive session

At 7:27 p.m. the Board returned from executive session.

Craig Leslie moved, reluctantly, to accept Bruce Shirky's request to withdraw as the judge for Chihuahua Club of America in spring, 2012 Jackie Dew seconded. Motion carried.

Show chair will check with next Judges on the list. Rey Burgos is next, followed by Sharon Newcomb.

**CHIHUAHUA CLUB OF AMERICA**  
**AKC MEDALLION FOR OUTSTANDING SPORTSMANSHIP**

The AKC Outstanding Sportsmanship Award program was established in 2006 to provide each member club with an AKC Medallion to award to one of its own on a yearly basis.

The sport of purebred dogs, embodied the AKC Code of Sportsmanship, and have been an active and valued member of an AKC member club. Medallions are awarded solely at the club's discretion.

**AKC CODE OF SPORTSMANSHIP**

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

**CRITERIA FOR SELECTING CCA MEMBER TO RECEIVE THE AKC OUTSTANDING SPORTSMANSHIP AWARD**

The recipient must be a member in good standing of the CCA for at least five (5) years. They must have undertaken substantial activities to promote the sport of purebred dogs, demonstrated a high level of commitment to the Chihuahua and embody the attributes outlined in the AKC Code of Sportsmanship

The recipient should regularly attend dog shows with their dog(s) and/or participate in activities (conformation, performance and companion) of the CCA and/or regional clubs.

This annual award will be presented to an CCA member at the annual award banquet for their contribution to the club/breed. Examples of such contributions might include spearheading a successful program, making a major contribution to the breed, organizing a successful fund raising effort, or "simply" a selfless act of kindness.

## **1. HOW WILL RECIPIENTS BE NOMINATED?**

Nominations should come from three (3) CCA members in good standing with an essay of 200 words on why the individual (or group) deserves to be nominated. The essay should describe the activities of this individual (or group) that makes them a worthy candidate and explain how this person exemplifies good sportsmanship as outlined in the AKC CODE OF SPORTSMANSHIP. The nomination will be sent to the CCA Secretary and received by April 1 of each year. If the CCA Secretary does not receive a nomination from the membership by April 1, the CCA Board can make the selection for the recipient of the AKC Outstanding Sportsmanship Award for that year. If no candidate names are submitted, or no candidate found to meet the criteria established by AKC, there will be no award. The CCA Board will then review the nominations, to make sure that they meet the standards as set forth by AKC. All suitable candidates will then be sent to the Election Chair, who will include the names in the annual ballot.

## **2. WHO WILL SELECT THE WINNERS?**

The award recipient will be selected by a vote of the membership of the CCA in a secret ballot, that will be returned to the teller. The winner will not be announced until the annual banquet at the Fall National Specialty.

## **3. WHAT ARE THE CRITERIA OF THE AWARD?**

The award will recognize an individual (or individuals) who has shown unparalleled examples of sportsmanship and who best exemplify the ideals of sportsmanship as outlined in the AKC CODE OF SPORTSMANSHIP, including but not limited to: fairness, civility, honesty, unselfishness and respect of the rules.

The individual will also have set a good example and acted responsibly in furthering the CCA's objectives:

- To encourage and promote quality in breeding of pure-bred Chihuahuas and if at all possible to their natural qualities to perfection.
- To encourage the organization of independent local Chihuahua Specialty clubs in those localities Club.
- To urge members and breeders to accept the standard of the breed as approved by the American Kennel Club as the only standard of excellence by which Chihuahuas shall be judged.
- To do all in its power to protect and advance the interests of the breed and to encourage sportsman like competition at dog shows and obedience trials.
- To conduct Sanctioned Matches, Specialty Shows, and Obedience Trials under the rules of the American Kennel Club.
- To promote the qualities of The Chihuahua breed to the members and general public through publications, educational seminars, library data banks, etc.

CHIC (Canine Information Center) provides a free health database that keeps records on all certified dogs. Instead of relying on a breeder's "claims of good health" of their dogs, pedigree research becomes verifiable by offering published official test results. The "unknown" is removed from the equation therefore bringing value to the breeding line by proving its health status.

# GME (Granulomatous Meningoencephalitis)

**Many people have never heard of GME (Granulomatous Meningoencephalitis).<sup>2</sup> This disease is becoming increasingly common, or at least, it is showing up more with the diagnostic techniques that are becoming more mainstream with dogs such as the use of MRIs and others.**

A number of Chihuahuas have now been diagnosed with GME. This includes Chis from all different lines in North America and in Europe.

Some Chihuahuas that were MRI scanned for Syringomyelia have actually been diagnosed as having GME instead.

GME is closely related to Pug Dog Encephalitis, Necrotizing Encephalitis and Necrotizing Leukoencephalitis, which also have very similar symptoms/causes/treatments as GME and have been diagnosed in Chihuahuas.[2,3,4] GME is a disease of the brain and spinal cord, generally thought to be autoimmune and possibly inherited.[2,3] This disease causes various neurological and behavioural problems as well as paralysis.[2] It is a serious disease, and although more common in female toy dogs than other breeds, it can occur in either gender.[1,3] Age of onset of symptoms can be anywhere from approximately 6 months old to 10 years, but it is more common in young to middle aged dogs and can happen at any age.[1,3,5] The life expectancy varies with the progression of the

disease and the location of the lesions, but ranges from only one week to a few months or a year from time of onset.[1]

Symptoms of GME vary according to where the lesions and inflammation are located. These symptoms can range from neurological problems (balance, pacing/circling, head tilt, leaning/falling, blindness, seizures) to problems with motor coordination and paralysis (sudden paralysis of the tail or other limbs and/or back pain, depending on the location of lesions on the spinal cord).[1,2,4,5] The most serious form of GME (Disseminated) causes lesions throughout the central nervous system including both the brain and spinal cord.[1] Prognosis is especially poor for this type of GME.[1] Many dogs end up dying from a seizure or are euthanized due to fast progression of symptoms.

Some treatment is possible including use of corticosteroids and other medications but unfortunately prognosis is generally very poor.[1,3,4] Depending on the type and severity of GME many dogs die or are euthanized even before a diagnosis can be made.[2] For more information about GME please visit the websites cited below.

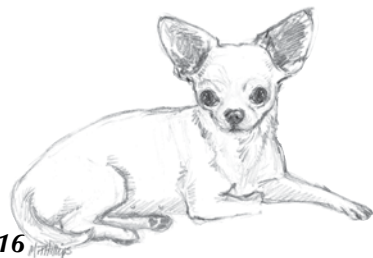

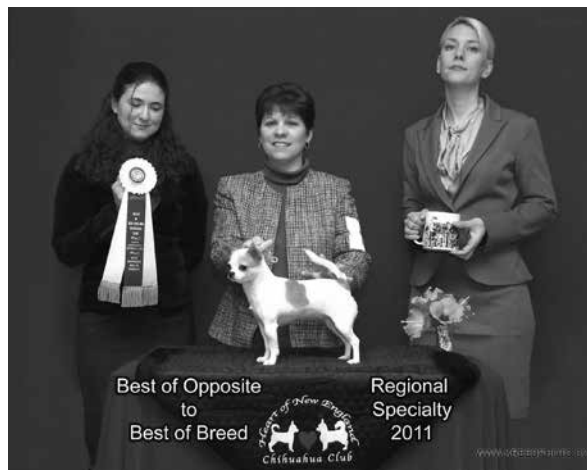

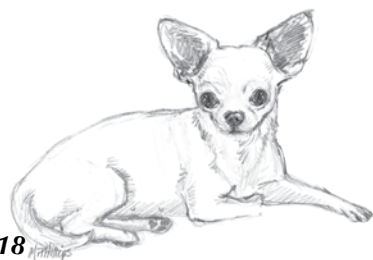

## **Grand Champions Can Now Earn Bronze, Silver, Gold and Platinum Designations**

The American Kennel Club® is pleased to announce a new enhancement to the Grand Champion program – Achievement Levels. Beginning May 11th, in conjunction with the implementation of the 2011-2012 AKC Point Schedule, Grand Champions will have the ability to earn the Bronze, Silver, Gold and Platinum designations at AKC all-breed, group and specialty shows.

The Bronze Grand Championship will require 100 points, the Silver Grand Championship will require 200 points, the Gold Grand Championship will require 400 points and the Platinum Grand Championship will require 800 Grand Championship points.

Upon reaching each level, owners will receive a special recognition medallion and certificate, and the AKC website will be updated monthly with

the names and breeds of all Bronze, Silver, Gold and Platinum dogs.

“We are happy to highlight the highest achievers in the Conformation ring with the creation of the Grand Championship Achievement Levels,” said Robin Stansell, AKC Vice President of Event Operations. “Many exhibitors brought their Champions back into the rings to complete the Grand Championship or continued showing when they normally would have stopped after obtaining a Championship title. The Achievement Levels give them an opportunity for continued recognition and achievement.”

The online GCH Breed Lists will be expanded from the top 25 to 100 dogs including Bronze, Silver, Gold and Platinum level designations. To keep up-to-date with the competition, a new Top 100 All-Breed Grand Champions list will be featured at [www.akc.org/grandchampionship/](http://www.akc.org/grandchampionship/)

Grand Championship judging will remain the same: all Champions of Record entered in the Best of Breed/

Variety competition will be eligible to compete for Grand Championship points at no additional entry fee, and points will be awarded, at the judge's discretion, to Best of Breed/Variety, Best of Opposite Sex, Select Dog and Select Bitch. Points are calculated using the same AKC Point Schedule as is used for Championship points. Once a dog completes the Grand Championship title, points will continue to accrue as it reaches the Bronze, Silver, Gold and Platinum levels; there is no reset. If a dog has already accrued 100 or more Grand Championship points since the beginning of the Grand Championship program, the Bronze, Silver, Gold and Platinum designation will be awarded retroactively.
