#### From the President:

1- Subsequent to our shows last month, some concerns were brought to the Board regarding administrative issues at the National. After reviewing the issues, the board felt it prudent to have an onsite representative of a licensed Superintendent to minimize these issues and/or misunderstandings.

The Board solicited contract proposals from six licensed Superintendents in regard to our Regional/National show in St. Louis next year. We asked specifically for a contract that included an on site Superintendent to set up the ring, handle the paperwork and deal with any issues that might develop. Of the six, only two submitted bids, Roy Jones and Onofrio.

After reviewing the services offered and the cost involved, the board has signed a contract with Onofrio to be our Superintendent for next year.

2- The board has appointed Jeff Yasenchok as Chair of the Illustrated Standard committee. This committee will work on producing a new Illustrated Standard for the club's use in Judge's Education Programs and to be used in handouts and on the website. This Breed Standard will be made available to all of our member clubs and for use when mentoring ringside. Rather than using actual photos, we would prefer to have one produced that is drawn.

The membership will be able to weigh in on which finished product they feel best represents our breed.

## **Guidelines for Plaques at Specialty Show**

CCA will offer a BOB plaque (or BOV plaques) and a HIT plaque (if obedience is offered at the local specialty) to CCA Member Clubs for presentation at their specialties. If notified by the member club in a timely manner; and if the CCA award(s) is published in the local member club's premium list, a copy of which must be received by the awards committee.

A letter, fax or email request for the CCA plaque(s) including the date of the event and the name and address of the individual responsible for obtaining/receiving the plaque MUST be received by the Awards Chair, Sandy St. John 727-641-2032 email to: <a href="mailto:kesacocker@aol.com">kesacocker@aol.com</a> well in advance of the events closing date. (We ask that you give her at least one month notice)

A premium list for the member club's event MUST also be received by the Awards Committee (a premium proof is

acceptable). The notice that the plaque(s) are being offered by CCA MUST be included in the events premium list even if it is a condensed premium list. If CCA's plaque(s) is not listed, NO plaque(s) will be mailed for the event.

It is the responsibility of each member Chihuahua Club to follow CCA's procedures for obtaining plaques for their specialty.

CCA member local clubs independent specialty, the CCA plaques will read: Chihuahua Club of America in recognition of Best of

Breed at a local specialty.

CCA High in Trial plaques for member clubs independent events will read: Chihuahua Club of America in recognition of High in Trial at a local specialty.

CCA member local clubs specialty held in conjunction with an All-Breed show, two CCA plaques will be offered, one for each variety. The plaques will read: Chihuahua Club of America in recognition of Best of Variety at a local specialty.

If a plaque(s) are offered, CCA will place an ad in the local clubs' catalogue wishing them a successful specialty and including the dates and locations of CCA upcoming specialties.

Once a year the Awards Committee using information from the current CCA membership roster will mail each local member club's secretary the requirements for obtaining CCA plaques for their specialty. The member clubs' procedure for obtaining the CCA plaques will be published in each Chi-Chatter. #### My Thoughts

What an honor it was to stand in the center of the ring at our National Specialty. I have had this honor once before. It is an honor that needs to be passed around to others. I will not accept another invitation to judge this event; however, I will continue to accept assignments for regional events and specialty clubs. Thank you to everyone that made both days truly enjoyable for me.

**Movement:** I was overall pleased with the movement of most entries. I would say that there are exhibitors that most probably have no clue what their dog looks like on the move. Dogs that cross in front or rear have no chance for a win under me. Dogs that bounce around the ring have no chance with me. It should have been obvious that I was looking for smooth movement, good reach and good drive in dogs I rewarded. Some exhibitors were unable to move as their dog wanted to move. This is unfair to the dog and severely limits my ability to reward the dog.

<u>Bites:</u> I was pleased with the overall entry regarding bites. If what I saw at our national is true of our breed in general, we have come a very long way. I also saw no disgustingly dirty teeth. Way to go exhibitors! I had entire classes where I could not fault any mouth. This finding is very contrary to what I have seen in the past.

**Tails:** A well placed, carried tail is such a nice finish to a deserving dog. I was disappointed in the number of "sloppy pug type" tails that were in the ring for competition. Equally offensive to me is the tail that lies on the back of the dog with no lift. Our standard is very clear as to how the tail should be carried. There are only three acceptable tail carriages. When standing at attention before the exhibitor, the tail is a critical part of the outline. I cannot reward improperly carried tails when there are many with correct tails.

**Ears:** No matter how much scissoring is done to the inside of an ear, the small ear does not appear larger to me. A small ear is simply a small ear. It does not deserve to be recognized in competition as stiff as the competition at our national. The total expression of a Chihuahua is very dependent on ears of proper size, placed well on the head and used to give expression.

There were several entries that really caused me to have a "warm fuzzy feeling all over my body". These dogs were the variety winners and opposite sex winners especially. The smooth coated puppy bitch that I awarded WB and BOS to was one of the prettiest puppies I have seen in my 58 years with this breed. Great things are expected from her in the show ring if she continues to mature as nicely as she was in St. Louis. Select dog in smooths was a dog I had not seen before. He is truly of exceptional quality, and it is my opinion that he can be expected to make his mark on our breed.

I was asked why I did not ask for exhibitors to pick up their dogs. I did not find this necessary given I never had a decision that hung on the head of any entry. I can see head on the table and if the dog is giving good expression on the floor I prefer to use this rather than a posed head study in the arms of the exhibitor. For me a correct Chihuahua is much more than a pretty head.

Congratulations to all my winners. It was a pleasure to have judged this prestigious event. Thank you for the opportunity.

It needs to be streamlined in order to be able to seamlessly transfer maintenance of the site to another webmaster in the future. The website is on a content management system called Joomla. The Website Committee proposes to migrate the site to WordPress, an alternate content management system. Our current system leaves us vulnerable to hackers and results in extended "down" time. WordPress will minimize this exposure. Another bonus to this migration to WordPress will results in our ability to take advantage of a program which will allow us to cross post information to our web site, Facebook, and member lists more efficiently, resulting in a more centralized location for members to obtain pertinent information. Myrle Hale made a motion to accept the proposal to migrate the website to a new content management service known as WordPress. Kathy Sawyer seconded. #### Amending the Constitution and By-Laws

The Chihuahua Club of America Constitution contains the fundamental principles and structure of our organization. The By-Laws outline the basic rules or procedure by which our Board and membership govern the organization. Article VII of the By-Laws provides a means for amending the Constitution and By-Laws:

## ARTICLE VII - Amendments **SECTION 1.**

Amendments to the Constitution and By-Laws and to the Standard for the Breed may be proposed by the Board of Directors or by written petition addressed to the Secretary signed by twenty percent of the membership in good standing. Amendments proposed by such petition shall be promptly considered by the Board of Directors and must be submitted to the members with recommendations of the Board by the Secretary for a vote within six (6) months of the date received by the Secretary. No two petitions germane to the same topic may be presented within one full year from the time it was voted on.

#### SECTION 2.

The Constitution and By-Laws and the Standard for the Breed may be amended at any time provided a copy of the proposed amendment has been mailed by the Secretary to each member in good standing on the date of the mailing, accompanied by a ballot on which a choice for or against the action to be

taken shall be indicated. Dual-envelope procedures described in Article IV, Section 4(d) shall be followed in handling such ballots, to assure secrecy of the vote. Notice with such ballot shall specify a date not less than 30 days after the date postmarked by which date the ballots must be returned to the Secretary to be counted. The favorable vote of 2/3 of the members in good standing who return valid ballots within the time limit shall be required to effect any such amendment.

#### SECTION 3.

No amendment to the Constitution and By-Laws or to the Standard for the Breed that is adopted by the Club shall become effective until it has been approved by the Board of Directors of The American Kennel Club.

The CCA Board received a petition to "Open the Constitution and By-Laws for Revision", signed by 20% of the membership in good standing, on October 10, 2015. This gives the membership the opportunity to submit proposed changes to the Constitution and By-Laws.

A copy of the entire Chihuahua Club of America Constitution and By-Laws can be found in the members section on the CCA web site.

Please submit your proposed amendments to any of the committee members listed above. Include a brief explanation of why you think the proposed change is necessary.

Each proposed change or addition must either enhance or clarify the understanding of an existing rule or add additional rules for the betterment of the club and its membership as a whole. At no time should a proposed change apply to an individual club member or a small group within the organization.

#### THE DEADLINE FOR SUBMITTING PROPOSED AMENDMENTS IS DECEMBER 31, 2015.

The committee will review all proposed amendments to determine their validity. The committee will seek CCA Board and AKC preliminary approval for all submitted amendments that meet the above criteria. Upon preliminary approval by the CCA Board and the American Kennel Club, a formal ballot will be prepared and sent to the general membership, along with the revised document, to vote for or against the proposed amendments. Per Article VII, Section 1, ballots must be submitted to the members for a vote by April 10, 2016, six (6) months from the date the petition was received. We will send the results of the membership vote to the American Kennel Club for final approval by the AKC Board of Directors. We will announce the ballot results to the membership at the general membership meeting in October 2016 and publish the results in the next Chi-Chatter issue following the general meeting.


