## *Guidelines for Plaques at Specialty Show*

---

**CCA will offer a BOB plaque (or BOV plaques) and a HIT plaque** (if obedience is offered at the local specialty) to CCA Member Clubs for presentation at their specialties.

If notified by the member club in a timely manner; and if the CCA award(s) is published in the local member club's premium list, a copy of which must be received by the awards committee.

A letter, fax or email request for the CCA plaque(s) including the date of the event and the name and address of the individual responsible for obtaining/receiving the plaque MUST be received by the Awards Chair, Marcy Blank 815-568-6450 or email to: [marcy@landschaftkennels.com](mailto:marcy@landschaftkennels.com) well in advance of the events closing date. (We ask that you give her at least a month notice )

A premium list for the member club's event MUST also be received by the Awards Committee (a premium proof is acceptable).

The notice that the plaque(s) are being offered by CCA MUST be included in the events premium list even if it is a condensed premium list. If CCA's plaque(s) is not listed, NO plaque(s) will be mailed for the event.

It is the responsibility of each member Chihuahua Club to follow CCA's procedures for obtaining plaques for their specialty.

CCA member local clubs independent specialty, the CCA plaques will read: Chihuahua Club of America in recognition of Best of Breed at a local specialty.

CCA High in Trial plaques for member clubs independent events will read: Chihuahua Club of America in recognition of High in Trial at a local specialty.

CCA member local clubs specialty held in conjunction with an All-Breed show, two CCA plaques will be offered, one for each variety. The plaques will read: Chihuahua Club of America in recognition of Best of Variety at a local specialty.

If a plaque(s) are offered, CCA will place an ad in the local clubs' catalogue wishing them a successful specialty and including the dates and locations of CCA upcoming specialties.

Once a year the Awards Committee using information from the current CCA membership roster will mail each local member club's secretary the requirements for obtaining CCA plaques for their specialty. The member clubs' procedure for obtaining the CCA plaques will be published in each Chi-Chatter.

# Chihuahua Club of America 2014 National Specialty-Judges Critique (Oct. 2014)

It was an honor and a great pleasure to judge the National Specialty once again. I feel the St. Louis facility worked out very well. Rooms were nice, shuttle service was great for those traveling by air, and many food places close by for those on foot like me-trying to avoid seeing exhibitors. My thanks to Show Chairperson Patricia Witter. She made things easy for the judges by handling all the details beautifully. Also thanks to Randy Carr who stepped in to ring steward and did a great job when Lynnne Bunten wasn't feeling well and needed assistance. Lynnne continued to help us from the side line. (Hope you are feeling back to normal Lynnne.) And as I believe you will all say after seeing photos on Facebook - a big thanks to the show photographer for her great work. I feel the show photos have been exceptional.

I previously judged the National in Chicago in 2003, Longcoats at the National the year it was in Phoenix and the Sweepstakes at Nationals three times, 1972, 1984 and 1997. I was most impressed with the progress of the breed this year. One of the biggest things that impressed me was temperaments and showmanship. There was hardly a dog, puppies included, that didn't stand beautifully for examination. There wasn't one dog that didn't wish to lead and almost all with tails up and happy. Front movement was better than I have seen in the past, rears were quite good, topline and tailsets much improved, heads were

good, and most had good bites. Keep up the good work folks!

It is often said that the Longcoats are much superior to Smoothcoats in quality. This didn't appear to be true this year. I felt the Smooths were every bit as nice as the Longs this year. And that is great considering they have everything right out in plain view.

It was a pleasure to judge such nice quality Chihuahuas and never hard to find a dog for the first place ribbon. Several times I wished I had four first place ribbons to give out. My very favorite class in both coats was the Stud Dog Class. Certainly could have used all 1st place ribbons. And classes of 45 and 50 Specials for Best of Variety is a breeder judges' dream but at the same time overwhelming.

Forgive me but I am not a fan of judges' critiques listing the merits/faults of every placement. I don't like reading them as every entry sounds alike and I especially don't like writing them. I will give my thoughts on some of the major placements.

## Longcoats

Winners Dog (53) from the BBE Class. Beautiful head, great coat and condition, nice movement, great topline and tailset and well bodied out, showed beautifully.

Reserve Winners Dog (75) from the Open Class. Larger male, very sound, great topline and movement, nice type.

Winners Bitch (72) from the BBE Class. Beautiful head, medium size, good legs and movement, refined and showed very well.

Reserve Winners Bitch (110) from the Open Class. Nicely balanced, mature, beautiful condition, pretty head, showed very well and very sound.

Best of Variety (105) Very well balanced dog, good head, good legs, topline, tailset and moved very well.

Best of Opposite Sex (134) A very flashy smaller bitch, very animated, beautiful type and great movement. Was asking for it every moment.

## Smoothcoats:

Winners Dog (225) - from the BBE Class. Beautiful head, great topline and tailset, Good legs providing good movement; and Showed great. Reserve Winners Dog (253) - Very nice overall, Well balanced, pretty head and good legs. A very clean cut looking dog.

Winners Bitch (206) - from the 6-9 Mos. Puppy Class. Lovely head, great front and front movement, nice overall, showed great.

Reserve Winners Bitch (268) - Nice sound bitch, good head, showed well and a little bit pregnant.

Best of Variety (280) - Gorgeous head with beautiful eyes and ears, great front, well balanced, nice movement. Best of Opposite Sex (285) - Pretty head, nicely balance, good movement,

At the end of my judging assignment I was presented with a very impressive plaque thanking me for judging the National Specialty. I was also given a beautifully framed show photo provided by James Lehman of my judging the Sweepstakes in 1972 and awarding Jim and his puppy dog Best Longcoat Male in Sweepstakes. Many commented that Jim and I both had hair back then (and it was dark!) I announced that this was to be my last judging assignment. It has been very enjoyable and I would encourage other breeder/exhibitors to consider judging, even if you are only interested in judging Chihuahuas. Thank you everyone and I will continue to see you in the ring as a fellow exhibitor.

## Chihuahua Club of America Board Meeting July 9, 2015

CALL TO ORDER The meeting was called to order @ 7.02 p.m. on July 9 2015.

ROLL CALL PRESENT: H. Craig Leslie, Marcy Blank, Donald C. Coughlin, Craig Eugene, Kyle Potts, Kathy Sawyer, Jill Hopper. Myrle Hale and Jim Hanke joined the meeting after roll call.

Kyle Potts made a motion to deviate from the current order of the Agenda. Myrle Hale seconded. Voting yes: Donald Coughlin, Jill Hopper, Marcy Blank, Kyle Potts, Craig Eugene, and Myrle Hale. Jim Hanke and Kathy Sawyer were not yet on call. Motion passed

MINUTES Jill Hopper made a motion to accept the minutes as corrected. Craig Eugene Seconded. Voting yes were: Donald Coughlin, Jill Hopper, Marcy Blank, Kyle Potts, Craig Eugene, Kathy Sawyer, Myrle Hale. Motion passed.

CCA Webmaster Jennifer Newton joined the call to discuss the Website Committee report. The CCA website is the Club's website. It needs to be streamlined in order to be able to seamlessly transfer maintenance of the site to another webmaster in the future. The website is on a content management system called Joomla. The Website Committee proposes to migrate the site to WordPress, an alternate content management system. Our current system leaves us vulnerable to hackers and results in extended "down" time. WordPress will minimize this exposure. Another bonus to this migration to WordPress will results in our ability to take advantage of a program which will allow us to cross post information to our web site, Facebook, and member lists more efficiently, resulting in a more centralized location for members to obtain pertinent information. Myrle Hale made a motion to accept the proposal to migrate the website to a new content management service known as WordPress. Kathy Sawyer seconded. Voting yes were Donald Coughlin, Jill Hopper, Marcy Blank, Kyle Potts, Craig Eugene, Kathy Sawyer, Myrle Hale. Jim Hanke was not yet on call. Motion passed. Jim Hanke joined the call. Jim Hanke made a motion to approve the Website Committee to make the CCA

account pages and Facebook groups compliant with Facebook rules. Don Coughlin seconded. Voting yes were: Donald Coughlin, Marcy Blank, Kyle Potts, Jill Hopper, Craig Eugene, Kathy Sawyer, Myrle Hale and Jim Hanke. Motion passed. Jen Newton was released from call.

SECRETARY'S report: Marcy Blank had not received a report from the previous Secretary.

TREASURER'S REPORT: Kyle Potts presented her Treasurer's report, listed below (see attached)

The President asked the previous Secretary to step down due to work obligations interfering with Secretarial duties. The President asked for the previous email vote regarding appointment of a new secretary to be ratified at this time.

Motion made by Kyle Potts. to appoint Marcy Blank as Secretary for the remainder of Joie Chandler's term. Seconded by Jim Hanke. Voting yes were: Donald Coughlin, Jill Hopper, Kyle Potts, Kathy Sawyer, Myrle Hale and Jim Hanke. Craig Eugene abstained. Motion passed.

Treatment for Disease Grant Status - \$1,000.00

4. 01827: Defining the Specific Species of Bacteria that Contribute to Canine Periodontal Disease:

Dr. Marcello Pasquale - \$1,500.00

5. 1731: A Novel Approach to the Understanding How

meningeoencephalomyelitis Develops in Dogs:

Dr. Nick D. Jeffery, BVSc, PhD, Iowa State University - \$2,000.00

Total Awards Amount Recommended: \$7,000.00

HANDBOOK COMMITTEE report: Pat Witter was not on the call but submitted her report below

The 2015 Handbook is currently in the process of being proofed by the handbook committee. We will be sending the first proof to Bear Associates and we will have it ready to be sent to the printer by August, to be available for distribution at the 2015 CCA National, St. Louis, in October.

1. We have contracted for 400 copies of the 2015 Handbook.
2. We will have them for sale @ \$45 each which will bring in a potential profit of \$18,000.
3. We plan on having 200 copies shipped to the Holiday Inn SW Route 66 in St. Louis for sale.

Bill McCollister has informed me because of his duties with the magazine that he no longer wishes to be the distributor of the handbook after October when the new committees are formed. The Board needs to decide where the extra 200 copies of the 2015 Handbook need to be sent, as well as the remaining copies of the 2005 and 2009 handbooks, for further distribution, so that we can let Bear Associates know.

After a brief discussion by the board it was decided that the additional 200 handbooks be sent to Marcy Blank for storage with the plaques and medallions. Marcy will be responsible to mail out individual orders of the handbook. Kyle Potts will be responsible for receiving and maintaining the online orders.

**RULES APPLYING TO MOTOR HOME PARKING**

The Chihuahua Club of America has adopted the following motor home parking rules to ensure the safety and well being of all motor home users and their guests while attending the 2015 Regional & National Specialties at the Holiday Inn SW Rt. 66 in St. Louis, MO.

1. The number of parking locations is limited to twelve (12). Motor home parking will be by reservation and advance payment only on a first-come first served basis. Reservations are first-come, first-served based on postmark. No reservations postmarked before August 1, 2015. If several reservations have the same postmark and accepting all of them would exceed the limit, a drawing will be held to fill the remaining vacancies and the others will be placed on a waiting list. # CCA GUIDELINES FOR HOTEL/MOTEL MAINTENANCE

Because some dog people have been irresponsible in safeguarding property of hotels, it is increasingly difficult to secure suitable housing for our shows, our members and our dogs. For this reason the CCA is issuing the following guidelines for exhibitors to ensure that we are welcomed at hotels/motels.

1. If dogs are exercised in the rooms, this must be done in exercise pens. Do not blockade the bathroom or closet, for example to accomplish this. To set up exercise pens, use heavy plastic that is provided in the Welcome Bag as a base, with multiple layers of newspapers on top, then place the exercise pen on top of the papers. ***NO SHAVINGS, PELLETS OR ANY OTHER MATERIAL OTHER THAN PAPER WILL BE ALLOWED.*** The heavy duty plastic is pulled up above the "piddle" line about 8 to 10 inches and secured with clips or clothes pins. Soiled papers must be removed and placed in plastic bags for ease of disposal. Do not expect the housekeepers to have to touch any soiled papers, and soiled papers must not be merely placed in wastepaper baskets, as the scent of excreta and urine will penetrate the wastebaskets. All rooms must be kept clean and smell clean. This protects curtains and furniture.
2. When dogs are left alone in the rooms, they must be left in their individual crates.. Even "unclimbing" dogs have been known to climb out of their exercise pens when left in strange areas. And "digging" dogs have dug their way through their plastic and continued digging through the carpeting. This requirement of keeping dogs in their crates thus protects the animals from escaping while housekeepers come in, and of course, protects the furnishings.
3. Dogs must not be allowed to run free in the room, whether the owner is present or not. Many a good dog becomes suddenly unhouse broken when it encounters strange odors in strange places
4. The hotel will provide a room for bathing dogs. Owners/exhibitors should bring their own toweling for bathing the dogs. Hotel/Motel equipment must not be used for cleaning up accidents; owners/exhibitors must provide their own cleanup material...paper towels, vinegar, Fantastic, and the like.
5. Most hotels/motels that permit the use of their facilities for dog shows have a policy limiting the number of dogs allowed per room. There will be a maximum of 10 dogs per room. This will be strictly enforced.
6. No dogs will be allowed on any carpeting, including lobby rugs, halls, guest rooms, showroom, etc.
7. No exercising of dogs (outside) in any areas, except those areas posted with signs as dog areas. Each person is responsible for cleaning up after their dog, inside and outside of the motel.
8. No dogs allowed outside of their crates, unless in an x-pen w/plastic, or in the show ring.
9. No dogs allowed in the lounge, lobby, banquet/meeting rooms and restaurants.
10. You must have plastic underneath your x-pens and crates.
11. Dogs **MUST BE** carried in and out through designated exits/entrances only.
12. Holiday Inn is a pet-friendly hotel. However, the only breed of dog that is allowed in the CCA show will be chihuahuas. No other animals will be allowed.
13. Rooms must be made available for maids to clean daily. Do not disturb signs will not be honored during the day.

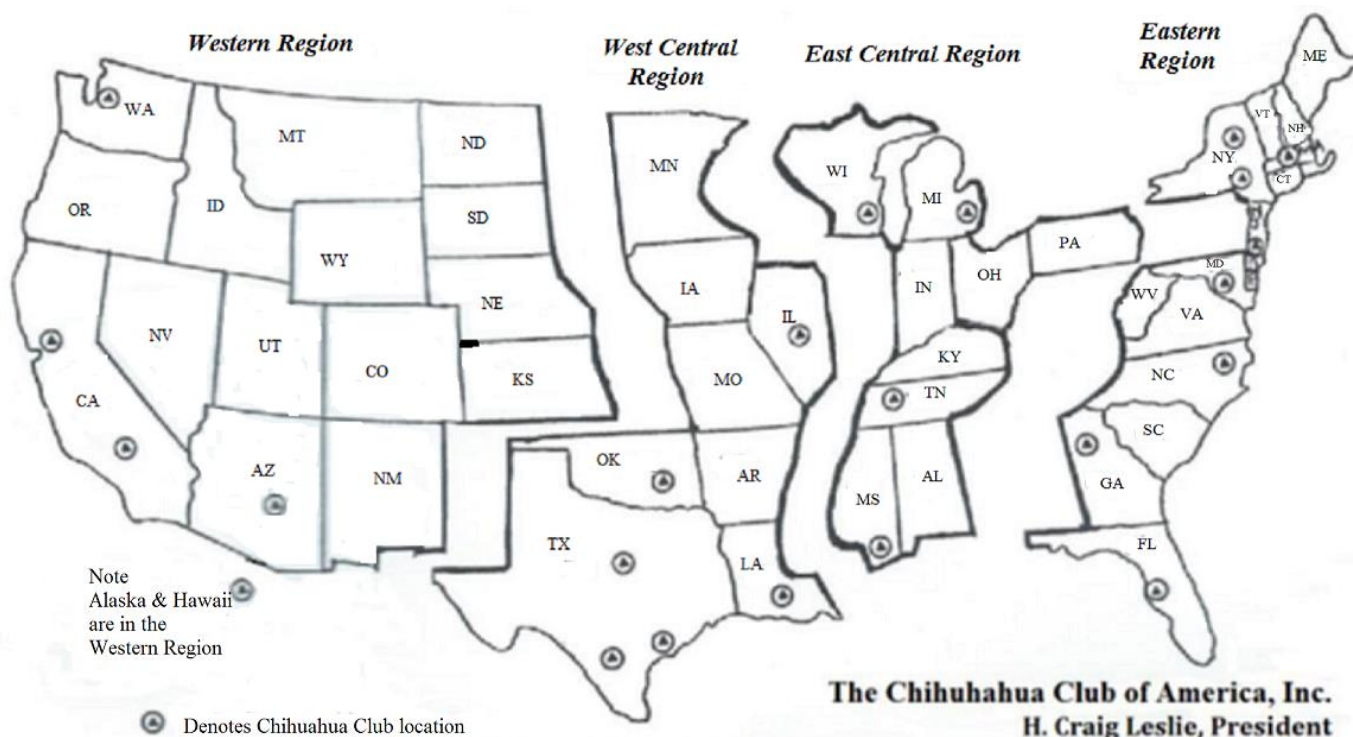
