## From Your CCA Board...

To all CCA Members,

The board would first like to thank all of the previous members of The Chihuahua Magazine committee that were clearly dedicated to producing a quality magazine of which we could all be proud. The planning, preparation and execution of the dream took over a year of long hours and hard work.

The first year of any publication is often like a honeymoon period. However, as with many other publications, after the first year the subscribers fail to renew for one reason or another and a business plan must be in place for that event if the publication is to survive. The CCA board asked for a business plan from the committee. Unfortunately for all, the committee perceived this request as a criticism of their work and most of the magazine committee resigned their position immediately. It is never a good thing when any volunteer feels unappreciated, and perhaps there should have been greater communication between the Board and all of the members of the Magazine Committee over the last year. Hindsight does not fix the hurt feelings, but it gives us guidance for the future. It is the hope of the board that, moving forward, the Magazine will continue to grow in both subscriber base and in content. To that end, we would like you to look at the questions posed below and give us your feedback.

The board has consulted with several people in the publishing field, both CCA members and non-members. We also had a telephone conference call on Thursday, February 25<sup>th</sup> with Mark Mogul of Bear Associates, the company that currently publishes The Chihuahua and has published both the Chi Chatter and Member's Roster in the past. Mark was very helpful, and shared a number of facts and suggestions with us. Both Mark and the other professionals that the board has consulted have given us great hope and some excellent suggestions for cutting costs, increasing the bottom line, and offering more back to our membership.

# Guidelines for Plaques at Specialty Show

CCA will offer a BOB plaque (or BOV plaques) and a HIT plaque (if obedience is offered at the local specialty) to CCA Member Clubs for presentation at their specialties.

If notified by the member club in a timely manner; and if the CCA award(s) is published in the local member club's premium list, a copy of which must be received by the awards committee.

A letter, fax or email request for the CCA plaque(s) including the date of the event and the name and address of the individual responsible for obtaining/receiving the plaque MUST be received by the Awards Chair, Sandy St. John at 727-641-2032 email to <a href="mailto:kesacocker@aol.com">kesacocker@aol.com</a> well in advance of the events closing date. (We ask that you give at least one month notice.)

A premium list for the member club's event MUST also be received by the Awards Committee (a premium proof is acceptable). The notice that

the plaque(s) are being offered by CCA MUST be included in the events premium list even if it is a condensed premium list. If CCA's plaque(s) is not listed, NO plaque(s) will be mailed for the event.

It is the responsibility of each member Chihuahua Club to follow CCA's procedures for obtaining plaques for their specialty. CCA member local clubs independent specialty, the CCA plaques will read: Chihuahua Club of America in recognition of Best of Breed at a local specialty.

CCA High in Trial plaques for member clubs independent events will read: Chihuahua Club of America in recognition of High in Trial at a local specialty.

CCA member local clubs specialty held in conjunction with an All-Breed show, two CCA plaques will be offered, one for each variety. The plaques will read: Chihuahua Club of America in recognition of Best of Variety at a local specialty.

If a plaque(s) are offered, CCA will place an ad in the local clubs' catalogue wishing them a successful specialty and including the dates and locations of CCA upcoming specialties.

Once a year the Awards Committee using information from the current CCA membership roster will mail each local member club's secretary the requirements for obtaining CCA plagues for their specialty. The member clubs' procedure for obtaining the CCA plaques will be published in each Chi-Chatter. If you are asking CCA to submit an ad for your catalog, you will need to contact the CCA Secretary, Marcy Blank 815-568-6450 or email to marcy@landschaftkennels.com The billing for the catalog insert should go to CCA treasurer Kyle Potts, 16619 Fort Oswego St, San Antonio, TX 78247 or email kylepottstx@aol.com

Mark spoke to us of his experience with the magazine since it began being published. Mark told us that he offered his opinion very early on that the subscription rate was too low, the advertising rates were too low and the cost to produce it was too high with the high quality paper and full color. He understood the committee wanting to make a splash while offering rock bottom prices, but he suggested that it was too grand of an idea for a magazine just entering the market. The other publishers all agreed. Mark commented that during the past year, his suggestions were overlooked and not implemented and unfortunately his fears have become a reality with a dwindling renewal of subscriptions as he expected. He did not feel that it was for lack of quality of content, rather he said it is the way of the magazine world. Many people will subscribe to a new, flashy magazine when it first comes out, but then when it's time to renew, it is an easy frill to cut out of their budget.

The numbers below were given to us by the previous magazine committee:

- Winter 2015 we printed 600 copies 110 were shipped to Bill McCollister and were all subsequently sold as single issues
- Spring 2015 we printed 663 copies. 35 were extras because they did not mail the International subscriptions.
- Summer 2015 we printed 639
- Fall 2015 we printed 675
- Winter 2016 we printed 575
   There are 221 paid subscribers of the magazine 127 subscriptions have not been renewed yet
   There were 385 members of CCA last year 135 members of CCA subscribed
   86 subscriptions are non-members

250 magazines were sent free of charge to AKC judges each issue One of the complaints brought to the board these past two years from many long time members is that they are not happy that the Chi Chatter magazine was taken away from them. They do not feel that they should have to pay extra to get the printed version of the Chi Chatter mailed to them, and they do not feel that they should pay the same price for The Chihuahua magazine as a non-member. We are continually asked "What do I get for my membership dues".

After researching much information, listening to professionals in the business and a great deal of discussion on the board, the board would like the membership's input on the following: The board would like to make the following proposals to the CCA Membership

- 1) Currently the club newsletter Chi Chatter is emailed to all members with email. Those members without email are sent a printed copy via USPS. The BOD would like to send the Chi Chatter at no charge to all CCA members requesting a printed copy. Those that prefer to receive it electronically will still be able to do so.
- 2) The Board proposes THE CHIHUAHUA magazine being included as a perk of CCA membership to be mailed at no charge to all CCA Members. To offset a portion of the cost of producing the Magazine, membership dues would increase by \$10 to \$35 a person. With that increase, members would still be paying considerably less than a current 1 year subscription. Another option is that members continue to pay for their subscriptions at a reduced rate, of \$24 from the current \$39 (If you prefer the option of all members receiving the magazine at no charge

and raising the dues by \$10 per person, would you consider a proposal to freeze the current Membership dues at \$25 for all CCA members who have belonged to the club for 20 years or more? This would guarantee those long time members that their dues would not go up in the future.) The subscription rate for non-members would increase to \$49 for 4 issues instead of the current \$39.

3) Mark Mogul from Bear Associates suggested that the current list of approved AKC judges that are receiving our magazine be sent a postcard asking them if they wish to continue to receive a complimentary copy. The judge would then be required to return the postcard if they wished to continue to receive the magazine. Many of us have family or friends who are AKC judges. The judges receive a huge volume of breed magazines every week, and most go to the trash, unopened and unread. By sending a postcard and asking for their interest, Mark feels that we can cut the number of free copies down significantly. Mark also suggested that if the number of judges who receive the magazine stayed high, we might consider sending the judges every other issue, or rotate the list of judges so that one half of them get one issue and the other half would receive the next issue. This seems to be an option that would be viable if the number of free copies being mailed to judges continues to exceed the number of paid subscriptions.


