

#### CCA Guidelines For Travel Assistance To Junior Members

Travel assistance will be available to junior members of the Chihuahua Club of America who are attending the National show in St. Louis each October. Travel assistance is available to those junior members who meet the following criteria:

- 1. The junior must be a current Junior Member of the Chihuahua Club of America
- 2. The junior must be between the ages of 9 and 18.
- 3. The junior must be entered in a Junior Showmanship Class at the Fall National show in St. Louis, Missouri.

Travel assistance funds are for the purpose of assisting the junior member with the cost of airfare or gasoline expenses while traveling to and from the Nationals. The funds are given to those juniors who are in a situation that requires monetary assistance to insure that the junior is able to attend the show.

The funds will be dispersed to the parents of the junior member. The funds allocated will be a maximum of \*(\$300). If the junior accepts the travel assistance funds and does not compete in the Junior Showmanship classes at the show, the funds must be reimbursed to the club.

Parents of the junior member may contact the Junior Committee Chair to apply for the travel assistance funds. The Junior Committee Chair will bring the matter to the Board for approval.

#### Guidelines for Plaques at Specialty Show

CCA will offer a BOB plaque (or BOV plaques) and a HIT plaque (if obedience is offered at the local specialty) to CCA Member Clubs for presentation at their specialties.

If notified by the member club in a timely manner; and if the CCA award(s) is published in the local member club's premium list, a copy of which must be received by the awards committee.

A letter, fax or email request for the CCA plaque(s) including the date of the event and the name and address of the individual responsible for obtaining/receiving the plaque MUST be received by the Awards Chair, Sandy St. John at 727-641-2032 email to kesacocker@aol. com well in advance of the events closing date. (We ask that you give at least one month notice.)

A premium list for the member club's event MUST also be received by the Awards Committee (a premium proof is acceptable). The notice that the plaque(s)

are being offered by CCA MUST be included in the events premium list even if it is a condensed premium list. If CCA's plaque(s) is not listed, NO plaque(s) will be mailed for the event.

It is the responsibility of each member Chihuahua Club to follow CCA's procedures for obtaining plaques for their specialty.

CCA member local clubs independent specialty, the CCA plaques will read: Chihuahua Club of America in recognition of Best of Breed at a local specialty.

CCA High in Trial plaques for member clubs independent events will read: Chihuahua Club of America in recognition of High in Trial at a local specialty.

CCA member local clubs specialty held in conjunction with an All-Breed show, two CCA plaques will be offered, one for each variety. The plaques will read: Chihuahua Club of America in recognition of Best of Variety at a local specialty.

If a plaque(s) are offered, CCA will place an ad in the local clubs' catalogue wishing them a successful specialty and including the dates and locations of CCA upcoming specialties.

Once a year the Awards Committee using information from the current CCA membership roster will mail each local member club's secretary the requirements for obtaining CCA plaques for their specialty. The member clubs' procedure for obtaining the CCA plaques will be published in each Chi-Chatter.

### From The President

Within our club we have members spanning multiple generations, and with that varying levels of preference and comfort in how s/he communicates. Some are very active on Facebook, others email, and some more comfortable via phone. Moving into 2017, one of my goals is to not just foster an environment where members feel comfortable communicating with the regional VPs, BOD members, and committee chairs, but also provide an additional means of doing so.

Currently CCA has the listsery, MailChimp, the website, the Facebook Fan page and of course emailing individuals. Approximately 62% of our members currently subscribe to the listsery and have this as a means of raising concerns. MailChimp is an excellent email/newsletter tool for announcements but of course provides no means for raising concerns.

CCA underutilizes the members section of the website. One of our goals is to post more information there so you, as members, can log-in and find much of the information you may need about the club, contacts, and any other news or announcements.

And then there is Facebook. CCA

currently has a fan page-which is an excellent tool for posting upcoming events, ways & means specials, or other information appropriate for a wider audience. There is also a Facebook group "CCA Member chat" which allows CCA members to chat amongst themselves. However, many may not be aware that the members of the BOD are excluded from this group and as such any concerns or suggestions made in the course of discussion are not reaching the ears of the BOD. I realize there is perhaps a need to vent, but if concerns are not brought to the attention of those who can answer or address them, it becomes unproductive. I would encourage those on this group to directly contact the committee chair, regional VP, or BOD if s/he has any specific questions or concerns.

In order to provide another option for communcation, in 2017 I am going to host quarterly open phone town hall style meetings by region to provide the membership an opportunity to voice concerns or suggestions. The meetings will last no longer than 1 hour. If no one calls in within 20 minutes of the start time of the meeting, the meeting will end. These will provide you with an opportunity to ask questions or even

make suggestions. I may not have an immediate answer, but will be sure the questions are answered by the appropriate party, and responses are posted. This is of course a pilot and the effectiveness will be evaluated in at the end of the 3rd quarter.

> General Committee Business: New committee members added for 2016 are Kris Bobo Specht & Cherry Parker. Kristi Green (existing member) will be the 2017 Committee Chair, and Anne, Liz & Karin are all remaining on the committee as existing members.

> The committee is currently regrouping and establishing our goals for 2017. CCA AKC-CHF DAF Fund: Balance: \$41,480.37 -- need a little help understanding what/when/where/how we allocate monies to studies from this balance:)

New CHIC Numbers

(Oct. 2016-Dec. 2016, 4th quarter): There were 25 new CHIC numbers issued to Chihuahuas in the 4th quarter of 2016. There were also 2 updated CHIC numbers.

1st Quarter 2016: 6 2nd Quarter 2016: 14 3rd Quarter 2016: 27

4th Quarter 2016: 25

• Ways & Means: Ways and Means 4th quarter report 2016 The Ways and Means committee had a very successful auction and sale at the National this year. We began the year with a balance in our account of \$12,216.23. We purchased 150 Rtic mugs (\$4070.00) as a fundraiser and have sold 90 of them to date. The income on the mugs sold to date has been \$3150.00, so we are well on our way to covering the entire cost of the mugs, and they will continue to bring income this year.

Our raffle at the show was a huge success, netting the club a little over \$3000 in profit. The current balance in our account is \$12,413.56. Due to popular demand, we have begun planning for the return of Chihuahua Bingo at next year's show.

Our current committee members are Terri Dejarnett, Paula Mc Swain, Kyle and Tracy Potts. I can also add the many volunteers that help at the nationals and make it all fun.

- Nominating Committee: No activity to report at this time of year.
- Regional: The update I have for the 2017 October Regional/National Show is that I have received signed contracts from our 2017 Sweepstakes judges, AND signed contracts from the 2018 Conformation Judges. Both judges elected at our 2016 Annual Meeting have accepted.

I have a signed contract with the new Show Photographer - Teddy Lei - who was at the show this year taking candid photos and will do the "formal" show photos as well as candid photos at the 2017 show.

As for the rest - I will start work on the various committees and advise you next year. As you know the one committee that does the most work before the show, the Top 20, we are fortunate that Michelle Brislin has agreed to take this on again for 2017.

Regional Orlando: The Florida Regional was a success. Thankfully Steve Hayden assisted as ring steward. He helped keep the ring running smoothly. Myrle Hale and Sharon Newcomb acted as ringside mentors. We had 19 Sweepstakes entries, 54 long coats, and 63 smooth coats. Total show profit \$912. 65 (see members only section of website for full details).

Top 20: Our Committee is requesting a budget of \$1500 for the year. The Top 20 Committee intends to raise the entry fee next year from \$75 to \$100. The reasoning behind this is that the meal cost is \$40 per person, \$50 for a ribbon and \$10 for a catalog, which lost money on each entry last year. The committee would rather break even where the entries are concerned and show any profit in the ticket and catalog sales. Entry fees would be \$100 which would include a page in the

- catalog, a ribbon and a meal Entry in catalog only would be \$75 which would include a page in the catalog and a ribbon Reserved tables of 10 would be \$450 Singles tickets would be \$45 Catalogs would be \$10 Extra ribbons would be actual cost of the ribbon, most likely \$50
- Judge's Education: The following people will be on the Judges Education Committee: They were chosen because they have expressed an interest in being on the committee or a couple that I drafted because they have been of great help in doing seminars. I've tried to include different areas of the country but would still like to find a member from the west coast. So far nobody has come forward. I'm open to suggestions on somebody to ask. Craig Eugene, Myrle Hale, Billy Miller, Dick Miller, Sharon Newcomb, Kenny Saenz, Kathy Sawyer, Joyce Standish, Pat Witter, and myself, as chair.

The Judges Ed Committee was asked to take on the illustrated standard project. Billy has tentatively agreed to take the lead on this sub committee. He has asked that Pat Witter and Bill McCollister work with him for their computer, photography, and artistic skills. I've asked that Sharon Newcomb be included because she was on a similar committee in another breed that just finished doing an illustrated standard. Billy and I would also like Myrle to be a consultant. Once the work is completed the entire committee will review it before submitting to the board. Billy believes there will be some art expenses but doesn't know how much right now. We would appreciate some input from the board on a budget.

A seminar was done at the CCA specialty last fall as usual. We have been asked to do a seminar in Louisville in March, which I'll be able to do. Craig Eugene has agreed to help me and I will ask some local exhibitors to provide dogs for the hands on. I understand that the Louisville

seminars are very well attended. Myrle mentored a couple people at the specialty during the Invitational week in Florida in December.

I received an e mail from AKC that had Chihuahuas listed as a breed that judges would have to do a front and side bite exam. I e mailed back that Chihuahuas should only be a front exam breed. The reply was that they had made a mistake and Chihuahuas should have been just a front exam. The error would be fixed. Since then one committee member said he thought the only way to determine a wry mouth was by doing a side exam. I believe a front exam is all that is needed and will not ask AKC to change to front and side unless the board decides otherwise

The AKC Meet the Breeds event held in conjunction with Westminster Kennel Club and TICA Cat Association on February 11, 2017 has been our second year running the booth. Half way through the day, the fabulous Chihuahua clothing designer and breed devotee Ada Nieves and Sophia Simillides Cotzia arrived with Amaretto and Beanie, and with a bag of Ada's designer outfits, replete with little sunglasses and hats. The others were promptly dressed in Chihuahua Couture and strutted their stuff happily.

Perhaps most enjoyable of all for us was several occasions we had families whose children asked to see specific dogs in attendance last year. It was quite a wonderful surprise! One little girl last year, this year being much taller, remembered Lola and wanted to see her again, stating that we had told her last time Lola didn't like to snuggle. When we had allowed her to hold Lola, she promptly snuggled into the little girl's hair and gave her kisses. Her parents told

us that she had been excited for this event for weeks and had asked to attend dog shows as well. Another boy now in second grade had asked to come so he could "see his little friend Peach" and asked many questions about showing. We had repeat attendance from adult spectators as well!

The highlight of our day, however, was a little boy named Turner dressed in the most dapper suit who cautiously and politely approached our booth. His mother informed me that she had brought him to see the cats and that he had been afraid of dogs since he was an infant they simply alarmed him for no known reason. Turner politely asked if he could "see Isaac up close" because he had heard the name and he sounded friendly. Little Isaac was dressed in a Louis XIV fancy "Sun King" outfit and Turner gently reached out to him, softly giggling as Isaac began licking his fingers. We spent about 20 minutes with Turner and his mother, during which time she told me through happy tears that this was the first dog he had ever touched, and had pulled her toward us "to go see the most beautiful puppies". I had a small print of a birthday card I painted for a friend for her birthday that had a Chihuahua in a space helmet jumping over the moon on it, and with his mothers permission I gifted it to little Turner. The little boy squealed with delight and thanked us, kissed Isaac, and said "How did you know I love space and I LOVE CHIHUAHUAS?!". His mother thanked us and said they would be looking forward to seeing us all next vear.

It is moments like this that make Meet the Breed so very important - Education and Positive interaction with Adults and Children alike with our beloved Chihuahuas! We invite any CCA members who have not yet participated in MTB that are attending the NYC Specialties/Westminster to join us in 2018, it is sure to be a great experience!



#### Winter ChiChatter Book Review

The Chihuahua by Anna Katherine Nicholas T.F.H. Publications, Inc. Neptune City, NJ, 1988



How many "The Chihuahua" books or pamphlets do you own? For me, there are more than I care to tell you about! So why do I want to share this one with you?

First, it's author, Anna Katherine Nicholas, is an award-winning writer of numerous dog breed books and magazine columns both in the United States and Canada. Her writing endeavors cover the 1930's through the 1980's. She was also a Dog Show judge in four groups. In 1970 she was only the third woman ever to judge Best in Show at Westminster as well as 16 other occasions over the years.

Her writing style is both to the point and easy to read and understand.

Secondly, this book has photographs of some of the top-winning dogs during the 1960s-1980s and their owners/handlers/breeders. You'll recognize kennel, dog and people names that may shed light on your breeding.

The book is broken down into 15 Chapters. As you would expect in a book with this title, there are the origin, development in the US, purchase, care, breeding, traveling-type chapters. It is interesting to see the author's take on a number of these topics and compare them to the present time.

For me, the meat of the book starts at Chapter 3: "Some Well-Known Chihuahua Kennels in the United States". The author goes into some depth, including where each of the 25 kennels reviewed started their blood-lines from and key winners and contributors to their success. Many of these kennels are still operating; the review starts with "Bayard" and concludes with "Will O'Wisp". You may recognize many of them.

Ms. Nicholas then goes on to discuss (including pictures) of "Some Early Best In Show Chihuahuas". She continues with individual chapters of Chihuahuas and kennels in Canada, Great Britain and Australia.

There are then 64 continuous pages of color photographs of smooth and long coat Chihuahuas that include the dog's registered name, breeders and/or owners names and the year of the photo and any accomplishment(s) of significance. There are also numerous other color and black and white photos throughout the entire book.

Chapter 2 - "Development in the United States", has a section that specifically talks about the Chihuahua Club of America. The discussion includes the founding date (1923), the group of fanciers that started the Club and where (New York metro area), the date of the initial specialty show (Sunday, May 19, 1928 in conjunction with the Queensboro, NY KC all-breed event). She then goes on to chronicle why the Specialty show was changed from NewYork to Chicago in the mid-1930s and who drove that move (the editor of Dog World magazine). She goes on to talk about CCA's Golden Anniversary in 1973. Did you know that a solid gold medallion was struck especially for this occasion?!? Nicholas then talks about the Club's decision in the mid-1970s to add an annual rotating spring specialty show to its schedule. The first such show was hosted by the Chihuahua Club of Atlanta in 1977; the 1978 host, the Chihuahua Club of Southern California, was the first time ever that the CCA annual meeting took place west of the Mississippi River.

Ms. Nicholas' The Chihuahua is another reference for our tool box to help us understand more about those who laid the foundation for today's Chihuahuas, and what those earlier dogs looked like. The more knowledge and understanding we have, the better our breeding and exhibiting will be. If we know where we came from, we can make better decisions on where we want to go.




